**A RESOLUTION OF MARTIN COUNTY, FLORIDA, TO INITIATE TEXT
AMENDMENTS TO THE COMPREHENSIVE GROWTH MANAGEMENT PLAN**

WHEREAS, the Board of County Commissioners of Martin County, Florida adopted the Comprehensive Growth Management Plan on February 20, 1990; and

WHEREAS, the Martin County Comprehensive Growth Management Plan, Section 1-11, Amendment Procedures, states that the Martin County Board of County Commissioners may, by resolution, initiate a request to amend, modify, add to, or change the Comprehensive Growth Management Plan; and

WHEREAS, on February 26, 2019, the Board of County Commissioners directed staff to initiate a Comprehensive Plan amendment to update the methodology for calculating population and future land capacity ensuring continuing maintenance of best management practices; and

WHEREAS, Chapter 163, Florida Statutes, requires local government plans to be based upon a professionally acceptable methodology for calculating population and land capacity; and

WHEREAS, it is recommended that the Board of County Commissioners amend Chapters 1, 2 and 4, and any other chapters necessary for consistency, of the Martin County Comprehensive Growth Management Plan.

MARTIN COUNTY, FLORIDA, THAT:**




