**A RESOLUTION ACCEPTING AND APPROVING A DRAINAGE, ACCESS AND MAINTENANCE  
EASEMENT FROM MCARTHUR GOLF CLUB, L.L.C., TO SUPPORT THE FACILITIES BEING  
CONSTRUCTED WITH THE OPENING OF SE CYPRESS AVENUE IN POINCIANA GARDENS**

WHEREAS, McArthur Golf Club, L.L.C., a Delaware corporation, (McArthur) is constructing SE Cypress Avenue to gain access to the McArthur West Golf Club; and

WHEREAS, the stormwater runoff from SE Cypress Avenue will be provided in and through the McArthur West Golf Club; and

WHEREAS, McArthur has agreed to provide a drainage, access and maintenance easement so the County may access those stormwater management facilities in the McArthur West Golf Club for perpetual maintenance; and

WHEREAS, by document entitled "Drainage, Access and Maintenance Easement", McArthur grants to Martin County a perpetual drainage, access and maintenance easement; and



## **DRAINAGE, ACCESS AND MAINTENANCE EASEMENT**

10<sup>th</sup> THIS DRAINAGE, ACCESS AND MAINTENANCE EASEMENT granted and executed this day of August, 20 22, by MCARTHUR GOLF CLUB, L.L.C, a Delaware limited liability company, whose address is 777 S. Flagler Drive, Suite 1500, West Palm Beach, FL, 33401, "Grantor" to MARTIN COUNTY, a political subdivision of the State of Florida, whose address is 2401 S.E. Monterey Road, Stuart, Florida 34996, "Grantee".

(Wherever used herein the terms "Grantor" and "Grantee" shall include singular and plural, heirs, legal representatives, and assigns of individuals, and the successors and assigns of corporations, wherever the context so admits or requires.)

WITNESSETH that the Grantor, for and in consideration of the sum of \$1.00 in hand paid by the Grantee, the receipt and sufficiency of which is hereby acknowledged, does hereby grant unto the Grantee forever, a perpetual drainage, access and maintenance easement on, over, under, across and through the land described and depicted on **Exhibit "A"** and **Exhibit "B"** attached hereto and made a part hereof (the "Easement Premises") for the maintenance, construction, installation and use of any surface and sub-surface drainage system necessary to ensure proper drainage, and the repair, maintenance, replacement thereof, and for ingress and egress across, over, and upon the Easement Premises as may be reasonably necessary, to carry out the purposes of this easement.

And the Grantor hereby covenants with Grantee that Grantor is lawfully seized of said land in fee simple, that Grantor has good and lawful authority to grant and convey this Easement, and that Grantor fully warrants the title to the Easement Premises, and will defend the same against the lawful claims of all persons whomsoever.

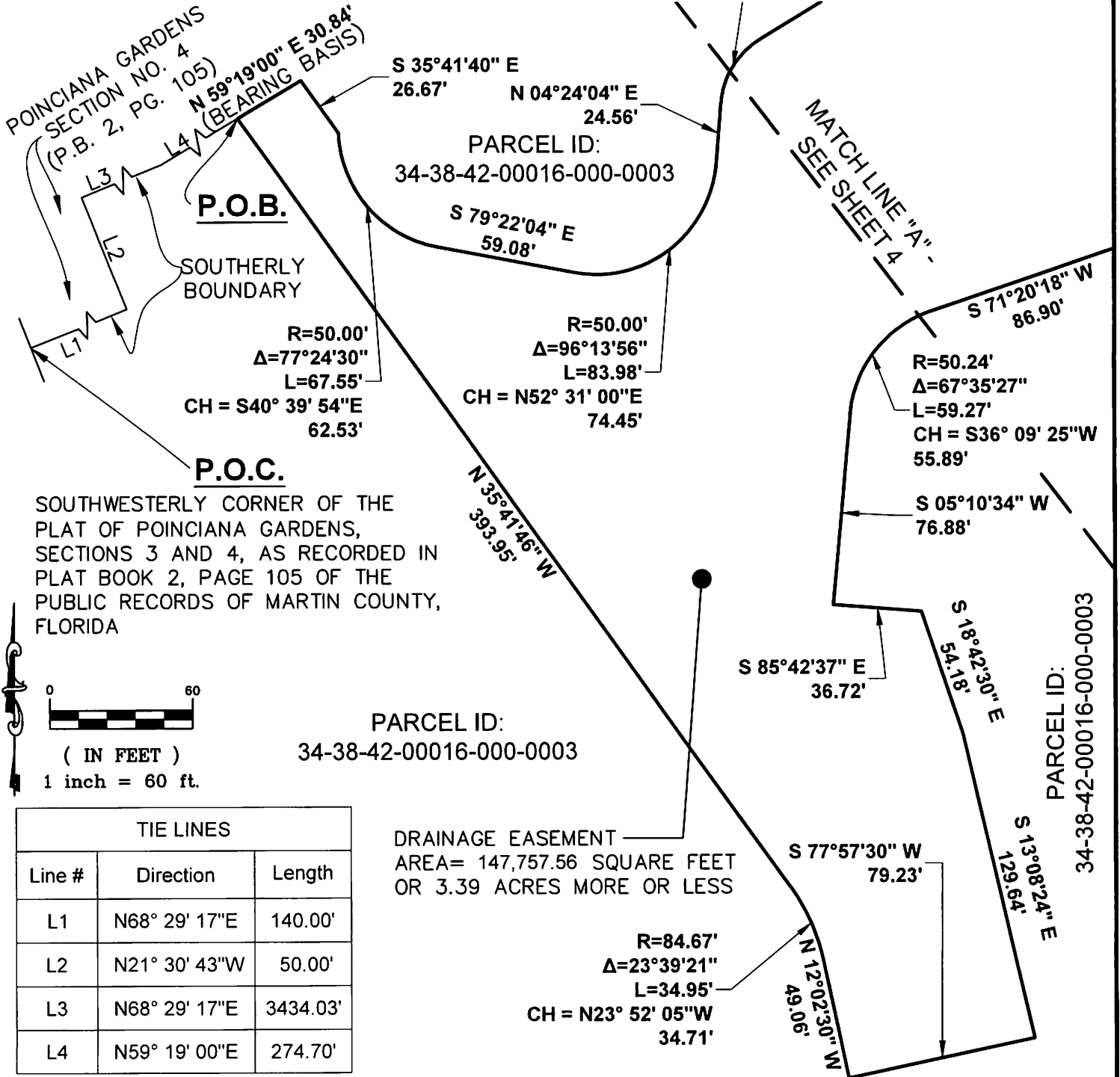

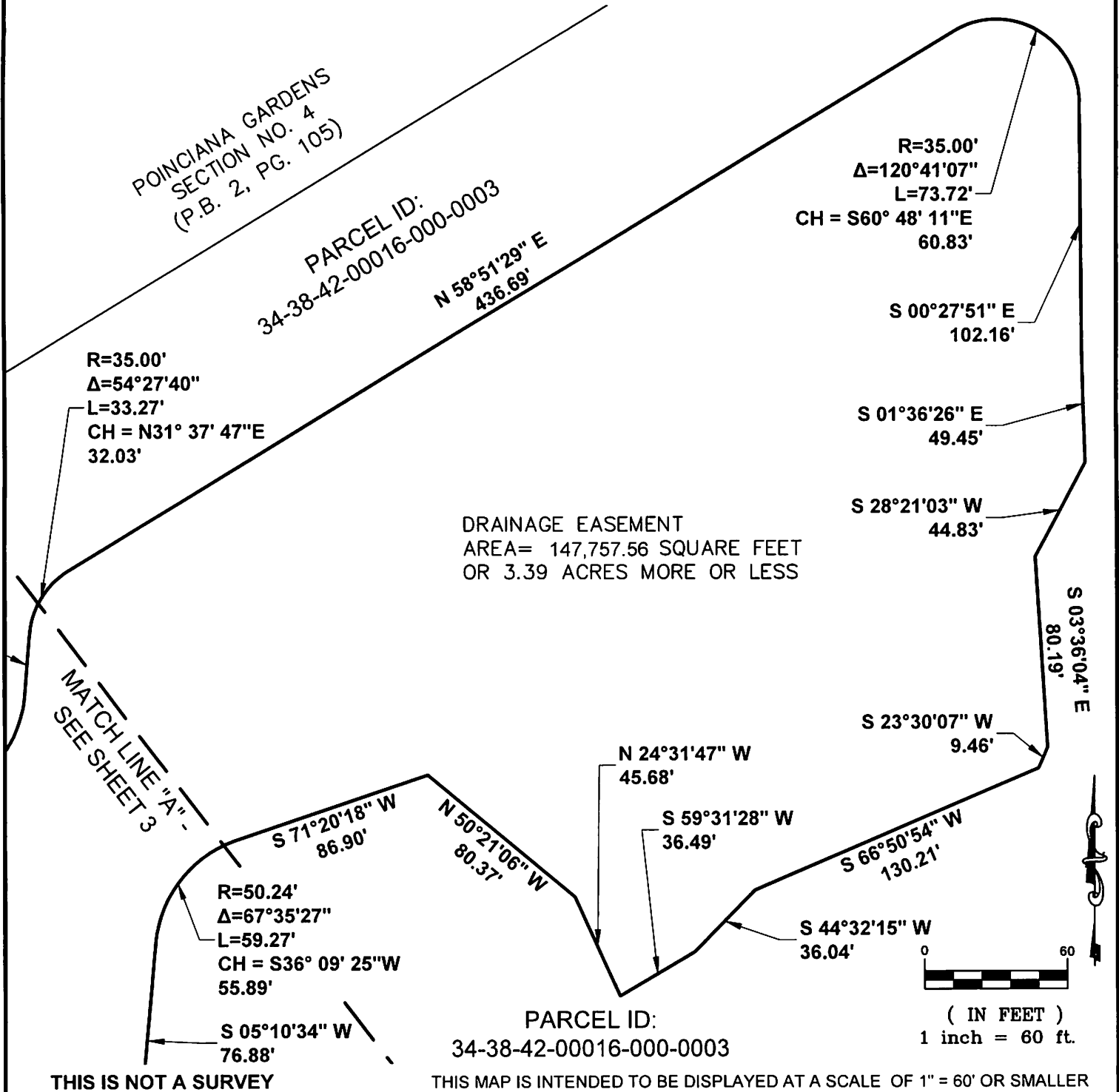

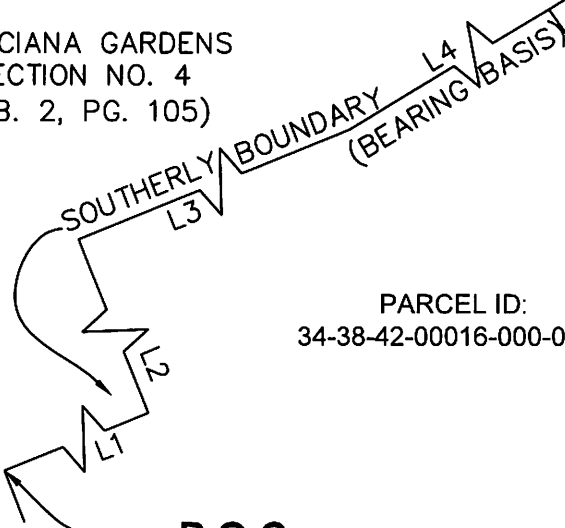
