TEAM GREEN MARTIN

WATER FEST

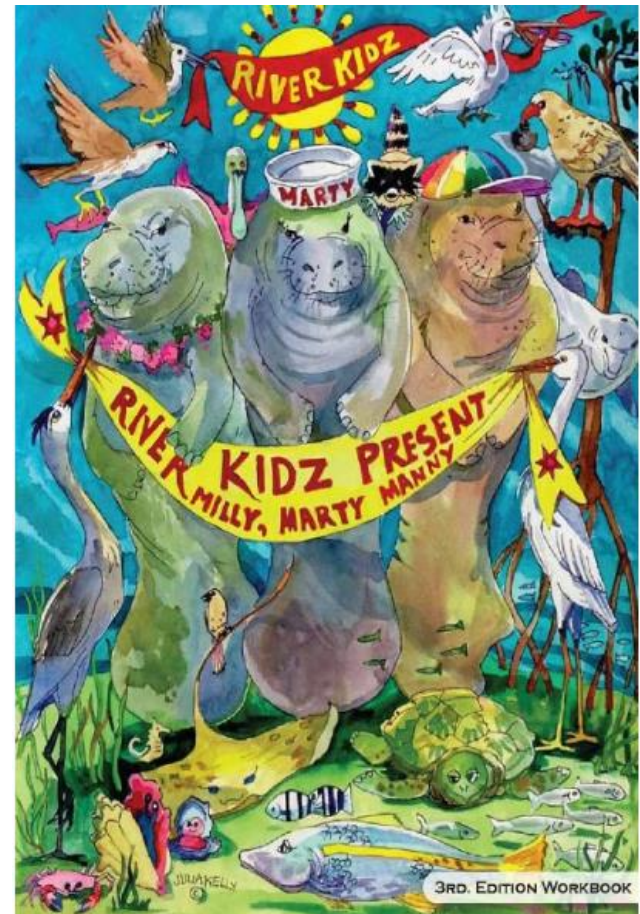


- Martin County Schools participated in a collaborative effort with Students 4H2O and the City of Stuart on March 23, 2018.

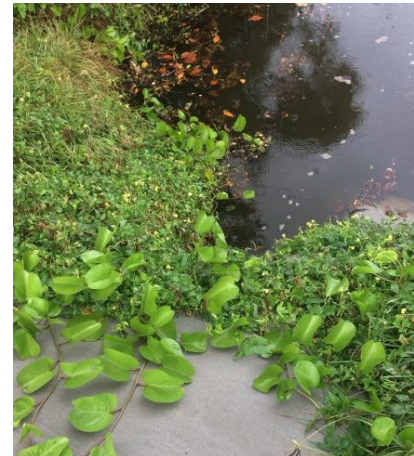
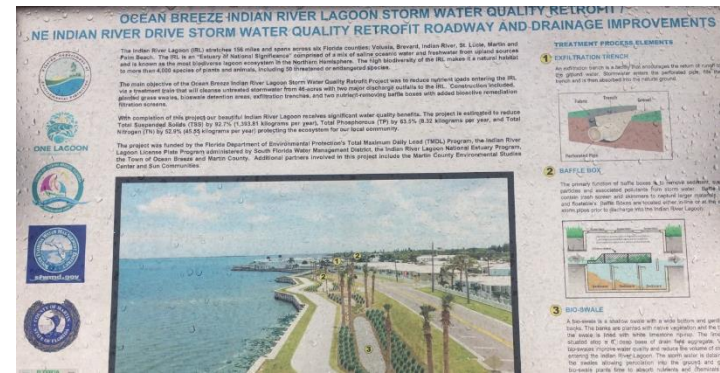
ENVIRONMENTAL STUDIES CENTER

FUTURE INITIATIVES

- **Waterventures:** The WaterVentures Learning Lab is a traveling environmental science center. This amazing vehicle is a 53 foot semi-trailer which has been customized to provide a platform for educational outreach programs. (We have had this program in the past and we are on a waiting list for this year.)
- **Teacher Externship:** Our district is currently partnering with FPL to provide a teacher externship for the summer of 2019.
- **NEED Project incorporated in our elementary schools:** National Energy Education Development Kids Teaching Kids philosophy as a fundamental principle of NEED programming – encouraging students to explore, experiment, and engage, and encouraging teachers to embrace student leadership in the classroom. NEED trains and assists teachers in harnessing the energy of the classroom – the energy of students.

HOMELESS EDUCATION

Homeless Education programs are necessary to support Families in Transition.

These programs are required by the McKinney-Vento Act (2000).

The McKinney-Vento Act was designed to specifically address the most common problems for homeless students:

- **enrollment**
- **attendance**
- **success in school**

HOMELESS EDUCATION

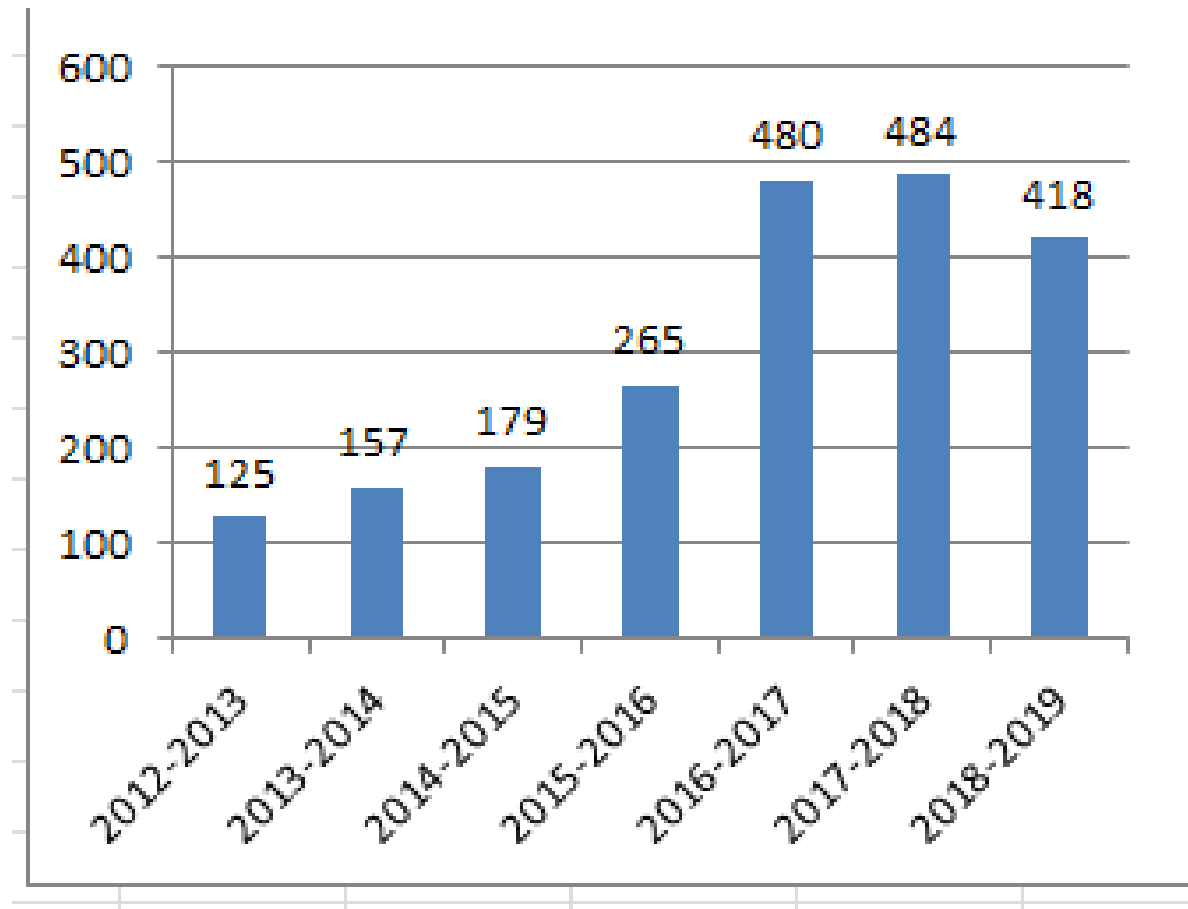
STUDENTS IN TRANSITION

- **reside in emergency shelters, hotels, motels, public places, cars, and/or substandard housing**
- **share housing due to loss of stable housing**

DID YOU KNOW?

- MCSD has over 400+ students who are homeless.
- The number has more than tripled in the last four years.
- More than 50% live in shared housing.
- Most FIT students are younger than 10 years old.
- A dozen or more live in unsheltered conditions (tents, public places).

FIT STUDENTS IDENTIFIED



CHALLENGES

Challenges to serving FIT students:

- **Reluctance to self identify**
- **Fear of Child Protective Services**
- **Absenteeism**
- **Forced transiency**

PROGRAM REQUIREMENTS

Local Education Agencies are required to:

- **Maintain confidential student records**
 - **Family Educations Rights and Privacy Act (FERPA)**
- **Keep student health records confidential**
 - **Health Insurance Portability and Accountability Act of 1996 (HIPAA)**

FIT STUDENTS

Students access includes:

- Breakfast and Lunch
- Clothing
- School Supplies
- Test Fee Waivers
- After School Care / Tutoring
- Transportation to school of origin
- Lending program for laptops and other academic tools
- Immunizations, eyeglasses, dental services and hearing aids

SUCCESS STORY

Jimmy moved to Martin County from Palm Beach county to care for a terminally ill family member.

When the family member passed away, Jimmy and his mom who also was ill became homeless.

They rented a small substandard RV to live in at this time.

Once the FIT coordinator met Jimmy, she empowered him with tutoring and basic school supplies he would need to be successful.
