**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF
MARTIN COUNTY, FLORIDA ADOPTING A ROADWAY TRANSFER
AGREEMENT WITH THE VILLAGE OF INDIANTOWN, FLORIDA TO
PROVIDE FOR THE TRANSFER OF ROADWAY MAINTENANCE AND
JURISDICTION OF THE LOCAL PUBLIC RIGHTS-OF-WAY WITHIN THE
VILLAGE OF INDIANTOWN**

WHEREAS, Martin County and the Village of Indiantown have mutually agreed to transfer all public road rights-of-way within the Village of Indiantown boundary, *except*

these collectors and arterials:

- SW Allapattah Road (CR-609);
- SW Citrus Boulevard;
- SW Farm Road;
- SW Fox Brown Road;
- SW Silver Fox Lane;
- SW Warfield Boulevard (SR-710); and

these privately maintained local road rights-of-way or easements:

WHEREAS, in compliance with Section 335.0415(3), Florida Statutes, it is necessary to enter into an agreement relating to the transfer of jurisdiction between governmental agencies for roadways.


NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY, FLORIDA, THAT:

The Board of County Commissioners supports the transfer of maintenance and jurisdiction of the foregoing described road rights-of-way from Martin County to the Village of Indiantown. Furthermore, Martin County authorizes the Chairman of the Board of County Commissioners to execute the Roadway Transfer Agreement attached here to as "Exhibit A" to effectuate the transfer and establish policies for future transfers.
