RESOLUTION NO. 19-2.1

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY, FLORIDA, RELATING TO THE REDUCTION OF THE MAXIMUM SPEED ON CR-708 (SE BRIDGE ROAD) BETWEEN SR-5 (US-1 / SE FEDERAL HIGHWAY) AND CR-A1A (SE DIXIE HIGHWAY) AND ON SE LARES AVENUE BETWEEN CR-708 (SE BRIDGE ROAD) AND CR-A1A (SE DIXIE HIGHWAY)

WHEREAS, Pursuant to Sec. 316.008(j), Fla. Stat., authorizes this Board to regulate the streets, highways and bridges within its jurisdiction, including altering or establishing speed limits; and.

WHEREAS, this Board has reviewed Staff's recommendation and has determined that establishing a maximum speed of 25 MPH and repealing the existing posted speed limit of 30 MPH on CR-708 (SE Bridge Road) between SR-5 (US-1 / SE Federal Highway) and CR-A1A (SE Dixie Highway) and on SE Lares Avenue between CR-708 (SE Bridge Road) and CR-A1A (SE Dixie Highway) is appropriate and is in the best interest of the Citizens of Martin County, Florida.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Martin County, Florida:

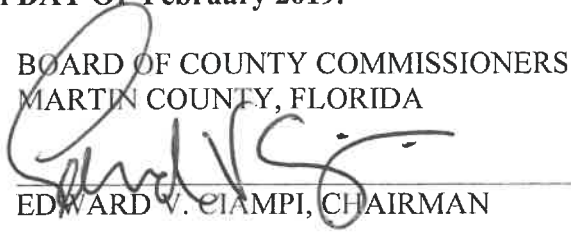
- A. The Board repeals all prior resolutions related to the speed limits on the above described portions of CR-708 (SE Bridge Road) and SE Lares Avenue; and
- B. The Board hereby establishes a maximum speed of 25 MPH on CR-708 (SE Bridge Road) between SR-5 (US-1 / SE Federal Highway) and CR-A1A (SE Dixie Highway) and on SE Lares Avenue between CR-708 (SE Bridge Road) and CR-A1A (SE Dixie Highway); and
- C. The Board hereby directs the Public Works Department to provide a copy of this Resolution to the Martin County Sheriff.

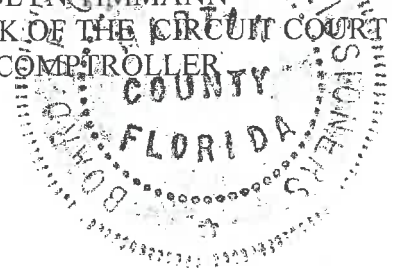
