**RESOLUTION NO. 19-7.2**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF  
MARTIN COUNTY, FLORIDA, RELATING TO THE INSTALLATION OF  
STOP SIGNS ON NW PINE LAKE DRIVE AT ITS RECONFIGURED  
INTERSECTION WITH NW SPRUCE RIDGE DRIVE**

**WHEREAS**, Pursuant to Sec. 316.008(b), Fla. Stat., this Board is authorized to regulate the streets, highways, and bridges within its jurisdiction, including regulating traffic by means of official traffic control devices; and

**WHEREAS**, the existing layout of the intersection NW Pine Lake Drive and NW Spruce Ridge Drive is unconventional and has STOP signs on NW Spruce Ridge Drive but not NW Pine Lake Drive; and

**WHEREAS**, at the request of the North River Shores Homeowners Association, staff presented three alternative layouts; and

**WHEREAS**, the North River Shores Homeowners Association selected the conventional four-way intersection; and

**WHEREAS**, the reconfiguration of the intersection can be incorporated into the Martin County North River Shores Neighborhood Restoration Project; and

**WHEREAS**, Martin County has adopted the Manual of Uniform Traffic Control Devices; and

**WHEREAS**, NW Pine Lake Drive is a County-owned and County-maintained major collector roadway and NW Spruce Ridge Drive is a County-owned and County-maintained minor collector roadway; and

**WHEREAS**, the County Engineer has determined that the four-way intersection of both collectors warrants a multi-way STOP condition.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Martin County, Florida:


- A. The Public Works Department is hereby directed to add two STOP signs on NW Pine Lake Drive at its intersection with NW Spruce Ridge Drive upon reconfiguration of the intersection; and
- B. The Public Works Department is hereby directed to notify the Martin County Sheriff's Office of this Resolution; and
- C. All previous resolutions related to the traffic control on NW Pine Lake Drive in the vicinity of NW Spruce Ridge Drive are hereby deemed null and void prospectively.






