RESOLUTION NUMBER 19-8.2

A RESOLUTION TO RELEASE THE UNITY OF TITLE FOR HUMANE SOCIETY OF THE TREASURE COAST, INC.

WHEREAS, this Board has made the following determinations of fact:

- 1. A Unity of Title was entered into by Humane Society of the Treasure Coast, Inc. and recorded in Official Records Book 1526, Page 0086, Public Records of Martin County, Florida, in consideration for the approval of a revised minor final site plan for Humane Society of the Treasure Coast which was approved on September 26, 2000, and recorded in Official Records Book 1526, Pages 0002, Public Records of Martin County, Florida.
- 2. Humane Society of the Treasure Coast, Inc. has requested that the Unity of Title be released in order to dedicate right-of-way to Martin County required in consideration for the approval of second revised minor site plan.
- 3. Humane Society of the Treasure Coast, Inc. will be required to provide a new Unity of Title as in consideration for the approval of the second revised minor site plan.
- 4. This Board considered such request at a public meeting on August 13, 2019.
- 5. At the public meeting, all interested parties were given an opportunity to be heard.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY, FLORIDA, THAT:

- 1. The Unity of Title entered into by Humane Society of the Treasure Coast, Inc. and recorded in Official Records Book 1526, Page 0086, Public Records of Martin County, Florida, attached hereto as Exhibit "A" is hereby released.
- 2. This Resolution shall be recorded in the Public Records of Martin County. A copy of this Resolution shall be forwarded to the applicants by the Growth Management Department subsequent to recording.

In consideration of the issuance of a Permit to The Humane Society of the Treasure Coast, Inc. as "Owner(s)" for the construction of a new building and parking lot in Martin County, Florida, and for other good and valuable considerations, the undersigned hereby agree to restrict the use of lands described in Exhibit "A" attached hereto in the following manner:

1. That said property shall be considered as one plot and parcel of land and that no portion of said plot and parcel of land shall be sold, transferred, devised, or assigned separately except in its entirely as one plot or parcel of land.

2. The undersigned further agrees that this condition, restriction and limitation shall be deemed a covenant running with the land, and shall remain in full force and effect, and be binding upon the undersigned, their heirs and assigns until such time as the same may be released in writing by the Board of County Commissioners.

3. The undersigned further agrees that this instrument shall be recorded in the Public Records of Martin County.
