

ADDENDUM TO MEMORANDUM OF AGREEMENT
FOR CONTRIBUTED FUNDS FOR THE JUPITER ISLAND BEACH
RE-NOURISHMENT PROJECT

This Addendum herby clarifies the intention of the parties relating to that Memorandum of Agreement executed between Martin County, Florida, political subdivision of the State of Florida, 2401 S.E. Monterey Road, Stuart, FL 34996 ("COUNTY") and the Town of Jupiter Island, a municipal corporation in the State of Florida, 2 Bridge Road, Hobe Sound, FL 33455 ("TOWN") on July 10, 2018 relating to Contributed Funds for the Jupiter Island Beach Re-Nourishment Project ("PROJECT").

WITNESSETH

WHEREAS, the TOWN and the COUNTY entered into a Memorandum of Agreement for Contributed Funds for the PROJECT on July 10, 2018; and,

WHEREAS, the PROJECT was successfully completed on May 4, 2019, placing a total of 1,173,000 cubic yards along the beaches of the TOWN; and

WHEREAS, the parties agree that the COUNTY's cost share contribution towards the PROJECT, to the extent not used in this PROJECT, shall serve as a credit for inlet bypassing in accordance with the State-adopted ST. Lucie Inlet Management Plan.

NOW, THEREFORE, in consideration of the aforementioned Memorandum of Agreement, the parties do hereby acknowledge and agree as follows:


1. In regard to paragraph number 4 of the July 10, 2018 Memorandum of Agreement, the parties agree that the PROJECT is complete and the COUNTY's contribution of \$8,941,498 is hereby acknowledged by the TOWN representing a project equivalent of 531,592 cubic yards of inlet sand bypassing in favor of the COUNTY.
2. Subsequent to any claims or grant reimbursements, any funds left over after PROJECT completion are to be retained by the TOWN's Beach Protection District held in reserves for construction, monitoring, restoration, etc. as needed and approved by the TOWN.
3. All other terms and conditions of the Memorandum of Agreement remain in full force and effect.




