

RESOLUTION NO. 19-10.15

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF
MARTIN COUNTY, FLORIDA, SUPPORTING THE PASSAGE OF
CONGRESSIONAL APPROPRIATION THAT PROVIDES FULL
FEDERAL FUNDING TO COMPLETE THE COMPREHENSIVE
EVERGLADES RESTORATION PLAN**

WHEREAS, as a result of activities to manage and drain water as early as the 1880s and more significantly through the construction and operation of the Central & Southern Florida (C&SF) project to make south Florida more inhabitable and facilitate agricultural production, the natural flow of water to, and through, the Everglades has been severely altered; and

WHEREAS, the construction of roads, canals and levees created barriers that now interrupt the natural flow of water, necessitating regular release of excessive volumes of freshwater from Lake Okeechobee to the St. Lucie River and Estuary that have degraded the ecology of the St. Lucie River and Estuary and nearshore reef; and

WHEREAS, upon congressional authorization for the Comprehensive Everglades Restoration Plan (CERP) in 2000 the U.S. State Army Corps of Engineers and the State of Florida entered into a programmatic 50/50 cost share partnership to restore, protect and preserve water resources in central and southern Florida, including the Everglades; and

WHEREAS, CERP is the largest environmental restoration program in the world; and

WHEREAS, the U.S. Army Corps of Engineers' Integrated Delivery Schedule (IDS) provides the sequencing strategy for planning, design and construction of federal projects based on ecosystem needs and benefits, and is a part of the CERP Programmatic Regulations; and

WHEREAS, these projects will provide significant lasting human health and environmental benefits, but will also enhance water supplies and maintain flood control for the region; and

WHEREAS, the benefits of CERP depend on the timely completion of all project components, and significant water quality improvements needed to prevent future human health and ecological hazards will not be realized until all projects are completed; and

WHEREAS, completion of all CERP projects depends upon Federal and State commitment of \$200 million annually; and

WHEREAS, the President of the United States encouraged Congress to provide \$200 million to CERP in the federal budget; and

WHEREAS, the United States House of Representatives approved H.R. 2740 appropriation which included \$200 million for CERP; and

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
MARTIN COUNTY, FLORIDA**

Section 1. The Board supports the agreed upon federal funding of \$200 million annually for CERP.

Section 3. The County Administrator is directed to transmit a copy of this resolution to the members of the County's Senate delegation.

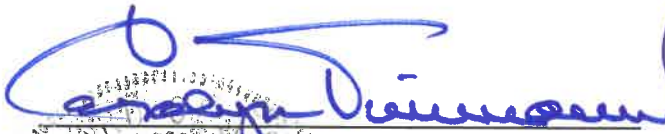
Section 4. This Resolution shall take effect immediately upon adoption.

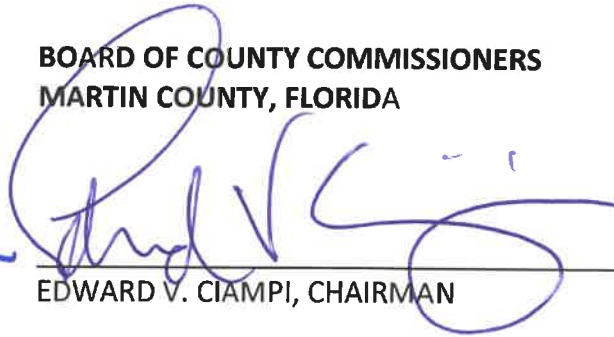
