At the special commission meeting of June 12, 2020 the CEO of Cleveland Clinic gave us the number of patients in the hospital battling Covid — 19.

l am reaching out to you in hopes that you can help myself & hundreds of other residents out here in Palm City Farms.

I am a resident of Palm City Farms for the past 19 years, a native born & raised resident of Martin County.

As I am sure you are already well aware, the drainage out here is an ongoing problem, especially after an unprecedented & significant amount of rainfall we have recently received.

I have recently been made aware of the "Palm City Farms Stormwater Modeling" study being completed by Singhofen & Associates, Inc. (SAI) for \$736,176.00. As you can imagine I was shocked to hear of such a large expenditure with absolutely no notice to any of the property owners out here in Palm City Farms that have been requesting the county to investigate the drainage issues out here for years. I do have a copy of the 36 page agreement between the county & Singhofen & Associates, Inc. (SAI) & I can see that our neighborhood is included in the study as we drain through the Danforth Creek Basin.

There is a large number of residents that are being negatively impacted by the poor drainage, continued intentional filling/blocking of county main or secondary ditches by property owners & even incorrectly sized culvert pipes.

As a resident of Martin County, I was disappointed to not have seen one county employee out & about in our Palm City Farms area checking & clearing clogged drains as a result of the recent ditch chipping that occurred, instead ourselves along with neighbors were out there with hand tools doing our best to clear the clogged drains & keep the flow of water moving along.

The constant ditch chipping is not helping the lack of depth of these ditches that have not been dug out since the neighborhoods were first established, only removing privacy between neighbors, clogging the culverts & leaving behind huge damage to the shoulders of the roads when the big excavator enters & exits the ditches. In years past the county would always come back & repair this

damage, now it is left to the property owners that abut these drainage canals to repair at their expense.

I tried reaching out to Mr. Gorton with nothing short of a dismissal reply scooting me over to the "public records liaison" for a records request??? I asked for a further explanation of the study.

What is the County hoping to get out of this study?
How will property owners benefit from this expensive study?
Will any work be done as a result?
I would like to know when the "public outreach portion" of the study will commence that has yet to be completed due to COVID19 delays???

In the recent past I spoke with you to try to get you to make sure our Martin County Storm Water Division increase their much needed maintenance of our storm water tributaries in Palm City Farms. I've had several sit down meetings together with Don Donaldson and Jim Gorton. Only to be advised by them excuses why they can't maintain the tributaries as they should.

"They run through private properties and we don't maintain private ditches" I advised them these ditches, except those dug by the homeowners into the tributaries, are mostly all on private property, which was known by the property owners when they purchased their properties, and what the tributaries purpose was. They were dug way back when by whoever, for the purpose of shedding the storm water run-off, and in the past have been maintained by the county. They have drastically eliminated that maintenance by excusing it off to this "private property" claim. I advised them and your legal department that the county owns the "prescriptive rights" to these tributaries because they have performed maintenance on them within the past 20 years and legal has concurred.

We have a neighbor that put a canoe in the Danforth at the end of Moore Street and took it East towards Citrus Boulavard. Only to find blockages with Pepper Trees and a very substantial blockage, of cbs concrete blocks, concrete bags and an intentional narrowing of the Danforth from the average of 25' wide and 6' deep in the rainy season, down to approximately 7' wide and 1' deep right now. He couldn't travel down the ditch any further. This particular landowner is impeading the flow of storm water and needs our code enforcement to pay a visit and have that taken care of immediately. Why would we, as tax paying property owners, have to take matters in our own hands, when things of this nature is the job of our Storm Water Drainage department?

I found out today that our commissioners agreed to pay for a private entity to do a study on our drainage system to the tune of 740k. In my last meeting with Jim Gorton, I was told they were

spending 60k for a proposed storm water study. I advised him that I wanted myself and everybody else in attendance (long time property owners with vast historical knowledge), be made a part of the preposed study to provide our imput before any implementation takes place.

How and why go through this tax payers expense, when stuff like this, and I can assure you, there's many more, can be found using a simple canoe?

This is not rocket science, just incompetence.

Lastly, for now, the retention pond off Leighton Farms Road is placed in the middle of the Danforth, and every bit of our water exits through a tiny 4' fixed weir. Severely backing up all the water flow in Palm City Farms. A total design disaster.

We would appreciate your assistance with all of this. Please.

Your Comment or Message: I filed a formal Request for Service on June 5, 2020 (Request No. 439466) and to date I have not received a response to my request. I live on Leighton Farm Avenue in Palm City Farms and although I have installed drainage on my own property, I have drainage ditches on 3 sides of my property that do not drain properly. As you are probably aware, the drainage ditches that run parallel to Leighton Farm Avenue flooded during the heavy rains we received. The reason for the flooding was not only due to the amount of rainfall we received but also due to the fact that the County does not clean out the massive amount of debris that accumulates in the ditches from foilage, litter and other refuse that is thrown into the ditches. Previously, I have had to physically clear out blockages in front of the culvert pipes in order for the water to drain properly. The flooding has caused the earth around the culvert pipe to collapse on either side of the driveway onto my property and is a hazard. Something significant has to be done to rectify this problem. If the County can't design a system that properly drains the water, the least they can do is have regular cleaning out of the drainage ditches. Finally, please have someone contact me regarding my Request for Service before the driveway onto my property fully collapses.

The comment made by one of the county commissioners and quoted by the local newspaper regarding the flooding at Hobe Heights has prompted this response.

I write this in hopes that you will consider this during your discussion of the situation in Hobe Heights at today's meeting.

The comment made was to the effect that landlords in the Hobe Heights neighborhood are renting flood prone properties to tenants without proper warning. Our company has been in business since Dec 2013. In fact, the 2 duplexes (4 rental units) which flooded were our first acquisition. When we acquired these units, we had no idea we were acquiring property prone to flooding. In fact, Martin County provides only the FEMA flood information which shows these properties as Flood Zone X, a safe zone not requiring flood insurance. How is this possible? The county public works director also reported to the press in response to the recent flooding, that he saw this kind of flooding in 1994. Where is the responsibility of the county in making this information available to possible home buyers and/or investors?

My partner and I are NOT slum lords, as we have been labeled since the commissioner's comments to the press. We spent over \$100,000 renovating these units to make them nice places to live. A new roof on one building, new windows in both buildings, new ceiling textures, all new kitchens (including cabinets and counter tops), new air conditioning, new wood trim, paint, soffets, new bathroom vanities and tile floors throughout. Before the flood these were very nice places offered at a fair rental rate. The flood has trashed the retirement, not to mention the time investment of my partner and I.

I feel for the single family property owners who were affected by this flood.
I also feel for the tenants who had to vacate our property due to the flood.

OVER ->

We did not create the flood, nor we did not ask for the flood. If we had known the properties were flood prone, we would have had flood insurance and insisted that our tenants had the same. Martin County, on the other hand, knew this flood was just a matter of time. With no notification to property owners and residents of the probable flooding, keeping their knowledge of prior flooding to themselves is inexcusable.

It is time for Martin County to do something about this. Property in the flood area should be purchased to increase flood water retention. There is no reason to let these property owners spend money to fix the damages, only to have it happen again. Buy the property NOW before additional funds are wasted. This will provide additional storage capacity to prevent flooding of other property in the future. As property owners, one of our options is to raise our buildings. This action will reduce retention area and our neighbors will flood next time. This is unreasonable.

Martin County has shown it can find funds to pay lawyers fees for Commissioner malfeasance and to fight train right of ways. It is time to quit saying you can find money for local emergency situations only if the state or federal governments provide it.

The City of Stuart Mayor, Mike Meier, City Manager, Mr. Dyess, and the City of Stuart Commissioners demonstrated leadership early in the pandemic outbreak, including wearing masks during all public commission meetings.

Their thoughtful consideration for the health and safety of their colleagues and the public served as a model for all residents, and emphasized that the City of Stuart is taking the pandemic very seriously.

Martin County Commissioners, on the other hand, have not once worn masks or face coverings during any of their public meetings, despite the recommendations of the CDC. The County Commissioners's lack of action has communicated the opposite message to residents -- that the lives of our friends, family and neighbors are not worth the inconvenience of their wearing a mask.

Nonetheless, the CDC and other infectious disease scientists highly recommend that ALL AMERICANS should be wearing face coverings to reduce the spread of the highly contagious COVID-19.

According to peer-reviewed scientific research published in the prestigious journal "Nature": "Surgical face masks significantly reduced detection of influenza virus RNA in respiratory droplets and coronavirus RNA in aerosols, with a trend toward reduced detection of coronavirus RNA in respiratory droplets. Our results indicate that surgical face masks could prevent transmission of human coronaviruses and influenza viruses from symptomatic individuals."

Requiring that all food service workers and employees who interact with the public to wear masks is an important first step, but much more is needed.

Hello commissioners,

I grew up in this county and went to school in this county. Because of this, I developed critical reasoning skills that are helpful with topics such as the recent surge in COVID-19 cases.

It has been proven time and again that this virus spreads on droplets, which are considerably larger than the virus. This leads to spreading of COVID-19, among other things. To prevent this, anything that blocks the spread of these droplets even slightly - in other words, any facial covering that prevents droplets from leaving the nose and mouth - will slow, if not outright prevent, the transmission of this virus.

Similarly, it is important to recall that the impact of masks continues to be made clear: places with widespread mask use are seeing a lower infection rate than those that do not require it. New York and New Jersey, while once hotspots, have dramatically reduced spread and eliminated the curve, even with the massive policy mistakes made early on. This is crucial, because it means that the virus spread can be contained via this simple procedure.

Lastly, I would like to direct you to the simple task of weighing your options. If you mandate masks and they work, then you have saved the lives of your family, your peers, and your voting base. If you do not, countless lives will be lost. Even if masks did not work (which they have been proven to do) and you mandate them, you have merely inconvenienced people slightly but not damaged their health. Those that wish to not use masks can go to work in another county if they are so inclined.

We have a higher spread in Martin County than in Palm Beach, Broward, and Miami Dade county right now - nearly one out of every 100 people in Martin County has COVID-19, and any associated long term health impacts that come with it. It is important to also note that these are infections from nearly a week ago now, as it takes an average of five days for symptoms to show and a day or two to

have a COVID-test performed and returned. The exponential growth adsociate with this likely means we are going to see an increase of over 50 cases a day for the next 7 days in Martin County eazily. Hospitalizations, as well as deaths, will rise starkly in about two weeks.

There is no treatment yet; there is no cure yet. Masks and social distancing are the only chance to get this under control, and to save many citizens of Martin County. Please do the right thing.

In the midst of a developing public health crisis, as evidenced by an alarming increase in the total number of COVID-19 cases, the percentage of positive cases over the state target of 10%, and the number of hospitalizations that threatens our health care workers and medical resources, you failed to agree on any measure that would show your commitment to protecting public health.

Yes, the medical community has taken the position that REQUIRING compliance is the RIGHT thing: that opinion is shared by many non-medical people as well, as evidenced by the many disappointed and angry comments shared on YouTube and social media throughout morning. But you did appear to find common ground on SOMEthing that could have shown a commitment by the BOCC to advance the common good. Instead, because you couldn't all get what you wanted, you gave the people of Martin County NOTHING. Today's county report with data through June 15 added over 70 new cases for a total of 1296, and 8 hospitalizations, 15 more since the data presented last Friday. What more do you have to wait to see this coming Friday? This situation is urgent. Some have proposed there is a point of no return after which face masks make little difference. Please do not leave today without doing SOMEthing; a well-crafted "strong recommendation" today could more easily become a requirement if the situation worsens later this week. If that recommendation motivates some people to wear masks or supports business owners who are trying to do the right thing, a few more people may be protected. If you decide to consider any recognition of businesses and restaurants that are or are not adhering to CDC guidelines, please remember that POSITIVE reinforcement has been shown to be the most effective method to change behavior. Also, any exemptions should reflect the CDC recommendations, namely "children under age 2, or anyone who has trouble breathing, is unconscious, incapacitated or otherwise unable to remove the mask without assistance."
