Unfortunately, she is not able to get her driver's license because the Martin County DMV is not open for this service. I tried to go to St. Lucie county and they would not help me because I was not a resident. Looking at the Covid-19 data as of 5/14/20, Martin county has 275 cases/6 deaths, St. Lucie County 299 cases/26 deaths, and Palm Beach county has 4,176 cases/254 deaths. Our neighboring counties to the north and to the south have MORE cases than our county but they have opened the DMV offices to ONLY their residents. I respectfully ask for you to open the Martin County DMV offices for the residents of Martin County to take care of services we need in our county following the CDC guidelines of social distancing.

Thank you for considering and implementing procedures to keep residents of Martin County safe. I agree with most of the decisions and the encouragement to wear masks. It's good to continue to keep our beaches open to Martin County residents only. Once other beaches south of us are open we can see how the people adhere to social distancing and no crowds gathering in one place. I just heard that the CDC has finally been able to send out a 9 page document with advice for reopening. Hopefully it will have a complete guide as to what we should do.

One concern I have is in regard to restaurants. Are they now open with inside dining at 25% capacity and recommending outside dining? It's already warm here, especially in the daytime at times.

Restaurants have ceiling fans outside in most of their outside dining areas. I think this would be a way to spread the virus. Some have ceiling fans inside. There are also AC vents all around the ceilings blowing air in various directions. Are AC vents safer than ceiling fans? Are we really safe? Maybe it's not possible, but should we continue to have delivery, pick up and carry out a little longer? Thankfully we have more testing, hence more counts, but the count is rising never the less.
