**RESOLUTION INCREASING THE OPC RIPPLE STORMWATER WATER QUALITY FUND REVENUES AND APPROPRIATIONS**

**WHEREAS,** The Board has approved applying for the Florida Department of Environmental Protection (FDEP) funding for the Old Palm City Ripple Stormwater Water Quality Retrofit; and

**WHEREAS,** A grant has been awarded for \$315,285 and Martin County is required to provide a match for \$97,000, which is currently budgeted within the Community Development Capital Improvement Plan; and

**WHEREAS,** Appropriations of unanticipated funds must be appropriated in accordance with Section 129.06(2)(d), Fla. Stat.; and
