- 1. In 2004, a Unity of Title was entered into by Ted Glasrud Associates of Deland Florida, Inc for a project known as Savannah Centre and recorded in Official Records Book 2092, Page 321, Public Records of Martin County, Florida. The project was never constructed.
- 2. Hope Center for Autism, Inc, the current owner of the property, has requested that the Unity of Title be released.
- 3. This Board considered such request at a public meeting on September 29, 2020.
- 4. At the public meeting, all interested parties were given an opportunity to be heard.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY, FLORIDA, THAT:

- 1. The Unity of Title recorded in Official Records Book 2092, Page 321, Public Records of Martin County, Florida, attached hereto as Exhibit "A" is hereby released.
- 2. This Resolution shall be recorded in the Public Records of Martin County. A copy of this Resolution shall be forwarded to the applicants by the Growth Management Department subsequent to recording.
