and will revisit in the future.

The Board reopened County Park restrooms effective today and the busiest ones will be cleaned twice daily.

The Board reopened racquet sports effective today practicing social distancing.

The Board reopened pavilions effective today practicing social distancing.

The Board directed staff to send a Chair letter of support encouraging the Governor to open all excluded businesses that can follow CDC guidelines.

The Board reopened the competitive side of the Sailfish Splash Waterpark pool practicing social distancing.

The Board reopened the beaches starting Monday and will reassess at the May 15 meeting but this exclude opening Hobe Sound Beach.

The Board asked staff to research if the County can regulate beaches and boat ramps to allow Martin County residents only.

The Board directed staff to enable phone-in capabilities for public comments at upcoming Board meetings.
