

### AMENDMENT TO AGREEMENT BETWEEN COUNTY AND CONSULTANT

THIS AMENDMENT #6 made and entered into this 3rd day of May, 2022, by and between MARTIN COUNTY, a political subdivision of Florida, (Hereinafter "County"), 2401 SE Monterey Road, Stuart, Florida 34996 and HJA DESIGN STUDIO, LLC (Hereinafter "Consultant"), 50 E. Ocean Blvd, Stuart, FL 34994.

#### WITNESSETH

**WHEREAS**, the County and Consultant entered into an Agreement RFQ2015-2767 dated April 6, 2015 to provide professional services related to the Martin County Golf & Country Club in the amount of \$104,650.00; and

WHEREAS, Amendment #1 for \$10,000 was approved administratively on June 15, 2015; and

WHEREAS, Amendment #2 in the amount of \$487,725 was approved by the Board on September 12, 2017 to move forward with design of the clubhouse, related support facilities and other golf course improvements; and

WHEREAS, Amendment #3 in the amount of \$37,373.44 was approved by the Board on May 7, 2019 to move forward with design of the clubhouse, related support facilities and other golf course improvements; and

WHEREAS, Amendment #4 in the amount of \$53,000.00 was approved by the Board on October 8, 2019 for additional clubhouse design and proshop renovation revisions; and

WHEREAS, Amendment #5 in the amount of \$44,500.00 was approved by the Board on June 16, 2020 for proshop interior redesign, range lighting addition and final civil engineering package for the Golf Clubhouse; and

WHEREAS, the parties desire to amend the Agreement to provide for Construction Administration services more specifically described in Exhibit A dated April 8, 2022 attached; and

WHEREAS, the County and Consultant have agreed to a cost for these services of \$22,500.00.

**NOW THEREFORE**, in consideration of the promises, covenants, and mutual benefits which all accrue to the parties hereto in carrying out the terms of this Agreement, it is mutually covenanted and agreed as follows:

- 1. The Agreement is hereby amended to include services outlined in Exhibits attached, and
- 2. The new total contract value is \$759,748.40; and
- 3. All remaining terms and conditions of this Agreement not specifically amended herein shall remain in full force and effect.
