Agenda Item: 22-0547, PORT SALERNO SHIP PROGRAM INFORMATION

Dawn Cobb, Housing Program Coordinator for the Martin County Health and Human Services Division, presented the possibilities of financial assistance to residents, especially regarding the recent water installation project being completed in the Port Salerno CRA.

The Martin County State Housing Initiative Partnership (SHIP) program is designed to provide Down Payment and Closing Costs for first-time buyers or to persons who have not owned a home within the last three (3) years. Home values cannot exceed \$334,249. Mortgage Preapproval is needed from a SHIP eligible lender, picture identification, and other qualifications must be met for the program.

The SHIP program provides up to \$40,000 in the form of a zero interest, deferred payment mortgage to qualifying homeowners (extremely low, very low, low, and moderate-income households) for home repairs. Repairs may include water/sewer hookup, roof replacement, electrical or plumbing, heating and cooling units, windows and doors.

Agenda Item: 22-0728, SALERNO "COLORED" SCHOOLHOUSE - NATIONAL HISTORIC REGISTRY Lloyd Jones presented information regarding the local historic schoolhouse built for African American children during segregation era and nominating this building to the National Register of Historic Places.
