Agenda Item: 22-0400, The Martin Apartments

Erika Beitler, HJA Designs, HJA Design Studio presented a proposed development of 30 apartments on the east side of SW Mapp Road between 27th Street and 28th Street. The total site is approximately 1.24 acres with a land use designation of "CRA Center" and a "Core" subdistrict.

Agenda Item: 22-0401, Old Palm City FY2023 Capital Improvement Plan

Susan Kores, Office of Community Development Manager, Manager presented capital improvement projects for the Old Palm City CRA in fiscal year 2023. Action requested: Hear the presentation and recommend via motion. Committee recommended to request an increase in TIF funds from 75% to 90% to be brought to the CRA Board and the Board of County Commissioners.

We received notice that we have been approved for grant funding through DEP and will hopefully go out to bid sometime after March.

Agenda Item: 20-0404, Ripple Stormwater Eco Art Project

Susan Kores, Office of Community Development Manager, presented the Ripple Stormwater Eco-Art project. All landscaping is complete except for Site 1 and the bioswale in front of Site 3 pavilion/dock. XGD is in the process of constructing both pavilions on Sites 2 and 3.
