## FINE REDUCTION STIPULATION AND AGREED RECOMMENDED ORDER

1. This Fine Reduction Stipulation and Agreed Recommended Order involves a parcel located at 3142 & 3152 SE HAWTHORN STREET, STUART, Martin County, Florida and further described as:

- 2. On June 19, 2013, an Order Finding Violation was issued by the Code Enforcement Magistrate to Orjan Ahlstrom, for the following violation(s):
  - Section 67.201.B Nuisance Declared: Trash, Etc General Ordinances, Martin County Code.
  - Section 67.201.A. Nuisance Declared: Weeds, Undergrowth General Ordinances, Martin County Code.

Compliance was required by July 5, 2013. On November 13, 2013, an Affidavit of Compliance/Accrued Fines was issued reflecting an outstanding fine of \$ 26,200.00 plus costs in the amount of \$575.00.

3. 3152 SE HAWTHORNE STREET LAND TRUST are the Current Owners of the property. Pursuant to a Deed to Trustee recorded in Official Records Book 2666, Page 1831, Martin County, Florida Public Records, Respondent has no remaining interest in the property.
