#### (AMENDING RESOLUTION SETTING THE SOLID WASTE FACILITY RATES AND REGULATIONS APPROVED ON AUGUST 16, 2016)

**WHEREAS**, pursuant to Section 151.172, General Ordinances, Martin County Code, the Board of County Commissioners, is authorized to charge a fee for disposal of solid waste at a County solid waste management facility; and

WHEREAS, Section 151.172, General Ordinances, Martin County Code provides that the amount of the County's fees shall be determined by the Board of County Commissioners by Resolution; and

WHEREAS, the Board previously adopted Resolution Number 16-8.1 on August 16, 2016 which set the rates for disposal of solid waste; and

WHEREAS, the Board has determined that it is in the best interest of the health, safety and welfare of the citizens of Martin County to amend the Resolution and set new Rates and Regulations for the Martin County Palm City II solid waste management facility according to Exhibit "A" attached hereto and made a part hereof, effective October 1, 2022.

## NOW, THEREFORE BE IT RESOLVED BY THE MARTIN COUNTY BOARD OF COUNTY COMMISSIONERS, THAT:

1. This Board hereby amends the Resolution in its entirety and substitutes in its place Exhibit "A".

1. The rates for all Solid Waste Facility users shall be in accordance with the following schedule effective October 1, 2022.

- c. Uncovered loads or loads received or completing transactions outside normal operational hours shall be at two (2) times the standard rate.
- B. Rates for FY24 shall be increased up to 7.6%. Rates for FY25 shall be increased up to 4%. Rates for FY26 shall be increased up to 4%. Rates for FY27 shall be increased up to 4%.
- C. Solid Waste Facility hours of operation: Monday thru Friday 8:00 a.m. to 5:00 p.m. All vehicles must be weighed in before

4:30p.m. The Transfers Station gates are closed at 5:00 p.m. All transactions must be completed and vehicles must be out of the site by this time or subject to the rate stated in A.4.c.

- D. Saturday 8:00 a.m. to 12:00 p.m. All vehicles must be weighed in by 11:45 p.m. The Transfer Station gates are closed at 12:00 p.m. All transactions must be completed and vehicles must be out of the site by this time or subject to the rate stated A.4.c.
- E. The landfill is closed on the following holidays: Memorial Day, Labor Day, 4<sup>th</sup> of July, Thanksgiving Day, Christmas Day and New Year's Day.

<sup>\*</sup>Alternative rates for Class I — Garbage shall be used only when scales are down and accurate weights are not available.
