- 1. <u>PERMISSION TO ACCEPT THE LOCAL AGENCY PROGRAM (LAP) SUPPLEMENTAL 2 GRANT</u> <u>FUNDING THROUGH THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) FOR THE</u> <u>RESURFACING OF CR 708 / SW BRIDGE RD. (CR 711 / PRATT WHITNEY TO SR 5 / US1) PROJECT</u> <u>(FM# 440811-1-58-01)</u>
 - Agreement/Contract drafted by FDOT
 - <u>Parties to the Agreement/Contract</u> FDOT and Martin County Board of County Commissioners
 - Purpose of the Agreement/Contract Supplemental Agreement 2 increases total funding for construction for the project by \$50,429. The revised LAP Grant Supplemental Agreement 2 amount is now \$3,266,723 of the project cost totaling 3,296,023.10. Refer to Exhibit "B" attached hereto and made a part hereof which replaces Exhibit "B" attached to the original agreement.
 - <u>New/Renewal/Modified</u> Addendum to Contract
 - <u>Duration</u> Martin County agrees to complete the Project on or before June 30, 2023 (date of Agreement expiration)
 - <u>Benefits to Martin County</u> To replace highly needed infrastructure and reduce maintenance. Policy 14.1A.10 of the Comprehensive Plan requires staff to identify project that eliminates public hazards and repair, remodeling, renovations or replacement of obsolete or worn-out facilities.
 - Cost to Martin County None

ALTERNATIVE ACTION:

- **<u>Programmatic Implication if not approved</u>** The project would be put on hold until an alternative funding source was identified.
- <u>Financial Fiscal impact if not approved</u> The County will forfeit \$50,429 in additional grant funding for the Construction of the project.

 - <u>Parties to the Agreement/Contract</u> FDOT and Martin County Board of County Commissioners
 - <u>Purpose of the Agreement/Contract</u> Grant award of \$336,772 to mill and overlay the pavement, replace taxiway lighting, and restripe Taxiway Alpha.
 - <u>New/Renewal/Modified</u> New
 - **<u>Duration</u>** Date of execution to December 31, 2024
 - <u>Benefits to Martin County</u> FDOT grant will cover 5% of the total cost of \$6,735,440 needed to construct Taxiway Alpha.
 - <u>Cost to Martin County</u> Local Share in the amount of \$336,772 will be provided from the Airport Enterprise Fund.

A revision to the Tentatively Approved FY23 CIP is needed due to the project coming in higher than estimated.

ALTERNATIVE ACTION:

- **<u>Programmatic Implication if not approved</u>** Airport will need to reprogram funding which would increase project time and cost.
- <u>Financial Fiscal impact if not approved</u> Airport will need to allocate approximately \$336,772 to construct Taxiway Alpha.
