

### DESCRIPTION

A PORTION OF A PARCEL OF LAND DESCRIBED IN THE WARRANTY DEED AS RECORDED IN OFFICIAL RECORDS BOOK 1504, PAGE 0597, PUBLIC RECORDS OF MARTIN COUNTY, FLORIDA.

BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

START AT THE NORTHEAST CORNER OF THE WEST 115 FEET OF GOVERNMENT LOT 5, SECTION 5, TOWNSHIP 39 SOUTH, RANGE 41 EAST; THENCE RUN N01°30'00"W, ALONG THE EAST LINE OF SAID WEST 115 FEET, A DISTANCE OF 374.64 FEET TO THE CENTERLINE OF THE OLD INDIANTOWN ROAD; THENCE RUN N47°04'30"E, ALONG SAID ROAD CENTERLINE, A DISTANCE OF 290.72 FEET TO THE POINT OF BEGINNING; THENCE S01°30'00"E A DISTANCE OF 469.50 FEET; THENCE RUN N88°30'00"E, A DISTANCE OF 300 FEET; THENCE RUN N29°45'00"E, A DISTANCE OF 450 FEET TO THE SHORELINE OF THE SOUTH FORK OF THE ST. LUCIE RIVER; THENCE MEANDER SAID SHORELINE NORTHWESTERLY TO AN INTERSECTION WITH THE CENTERLINE OF THE OLD INDIANTOWN ROAD; THENCE RUN SOUTHWESTERLY, ALONG SAID ROAD CENTERLINE TO THE POINT OF BEGINNING; LESS ROAD RIGHT OF WAY, ALL IN GOVERNMENT LOT 1, SECTION 5, TOWNSHIP 39 SOUTH, RANGE 41 EAST.

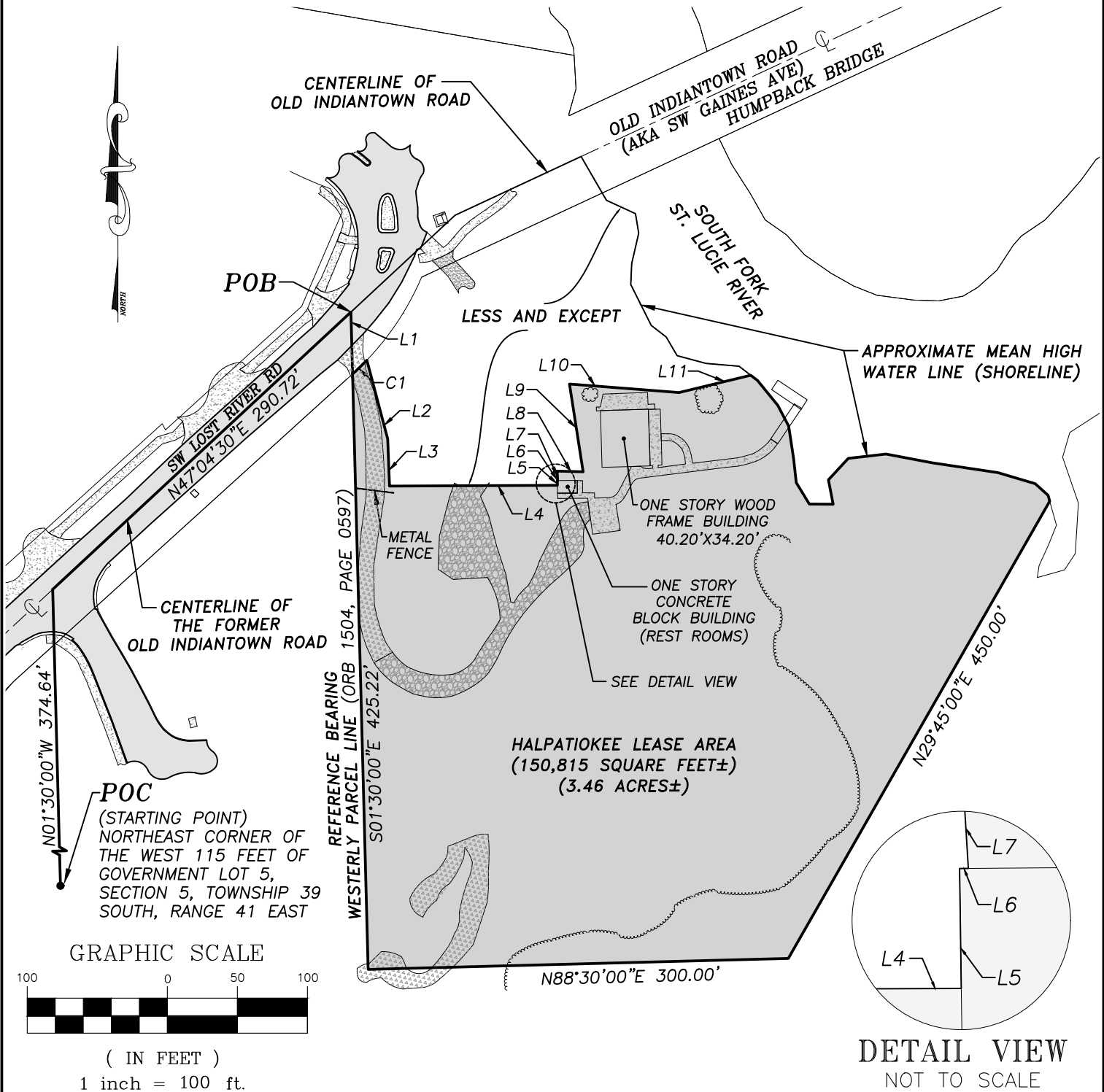
