- 1. PERMISSION TO APPLY FOR THE FEDERAL TRANSIT ADMINISTRATION (FTA) FY21 SECTION 5307

 AMERICAN RESCUE PLAN ACT URBANIZED AREA FORMULA FUNDING
 - Requestor Public Works
 - Granting Agency FTA
 - Project Description Martin County is a Designated Recipient of FTA funding and is therefore eligible to apply for Section 5307 American Rescue Plan Act (ARPA) Urbanized Area Formula funds. On March 11th, 2021, the ARPA was signed into law providing \$30.5 billion in federal funding to support the nation's public transportation systems as they continue to respond to the COVID-19 pandemic. Martin County is eligible to receive \$611,287 in operating assistance under the Urbanized Area Formula Program (49 USC 5307). This funding will be provided at 100-percent federal share, with no local match required, and is for operating expenses incurred beginning on January 20, 2020, to maintain transit services, prevent, prepare for, and respond to COVID-19. As with all Section 5307 grants, at least 1% of the ARPA apportionment must be used for public transportation security projects, and at least 0.75% must be used for public transportation safety projects. To comply with 49 U.S.C 5307 (b)(1) and (b)(7) the program of projects (POP) is as follows:
 - Requested Grant Award: \$611,287
 - Program of Projects (POP)
 - Operating Assistance: \$600,589Security Enhancements: \$6,113
 - Safety Enhancements: \$4,585
 - Requested Grant award \$611,287
 - Budgetary Impact No match is required
 - Annual operating costs Staff time to administer the grant.

- 2. PERMISSION TO APPLY FOR THE 2023 STATE WATER-QUALITY ASSISTANCE GRANT OPPORTUNITY FROM THE STATE OF FLORIDA, DEPARTMENT OF ENVIRONMENTAL PROTECTION NONPOINT SOURCE POLLUTION MANAGEMENT PROGRAM
 - Requestor Public Works Department, Field Operations and Stormwater Division
 - **Granting Agency –** Florida Department of Environmental Protection (FDEP)
 - Project Description Grant funding and the local match will be used to facilitate a series of public citizen science workshops. The workshops will be set up to engage and teach local stakeholders on the best management practices needed for freshwater lakes to function. We all depend on the lakes functioning as intended to clean and hold stormwater runoff. Freshwater lakes are the backbone of community stormwater systems. The workshops will teach the public about what is occurring below the surface and how the right lake management practices can help reduce the burden on the downstream stormwater infrastructure and impaired water bodies. Attendees will plant beneficial submerged plants, such as Florida native Vallisneria americana and Ruppia maritima, to improve water quality in County maintained stormwater treatment facilities. Attendees will also learn how they can support Martin County or other organizations with water quality monitoring and citizen science projects.
 - Requested Grant award \$60,000
 - <u>Budgetary Impact</u> The agreement requires matching with local funds in the amount of \$40,000. Match will be provided utilizing the Ecosystem Restoration and Management Division Total Maximum Daily Load (TMDL) funds.
 - Annual operating costs Staff time to administer the grant.

ALTERNATIVE ACTION:

- <u>Programmatic Implication if not approved</u> The County will not conduct beneficial submerged planting and citizen science workshops.
- <u>Financial Fiscal impact if not approved</u> Alternative methods may be needed to meet and exceed FDEP TMDL credits for Martin County.

3. PERMISSION TO APPLY FOR THE CHILDREN'S SERVICES COUNCIL GRANT PROGRAM – AFTER SCHOOL/OUT OF SCHOOL (AS/OS) PROGRAM GRANT

- Requestor Parks and Recreation
- **Granting Agency** Children's Services Council of Martin County, Inc.
- Project Description These programs are essential to the growth and development of Martin County youth. These County-run programs have been funded by Children's Services Council since 1994. The funding will pay for the staff, maintenance, supplies, and programming at Golden Gate Alternative Afterschool Program (G.A.A.P) at Lamar Howard Park in Golden Gate (Stuart), the Jensen Afterschool Experience (J.A.S.E) program at Langford Park in Jensen Beach, and the Residents Empowering All Children's Hope (R.E.A.C.H) program at New Monrovia Park in Port Salerno. These programs will include homework help and educational components, physical fitness, social-emotional learning, outdoor recreation, cultural exposure to arts, dance and music, as well as providing safe afterschool and summer care to those that are not able to afford it in any other capacity. The funding also pays for the TEEN program, providing quality activities and events for teens in the community in a safe setting. The program funding runs from October 1, 2023 September 30, 2024.
- Requested Grant award Up to \$400,000
- <u>Budgetary Impact</u> Grant match is currently budgeted in the FY23 Parks and Recreation budget.
- Annual operating costs Staff time to administer the grant.

ALTERNATIVE ACTION:

- <u>Programmatic Implication if not approved</u> If not approved, the After School Programs: GAAP, JASE, REACH, as well as the county-wide teen program will no longer be able to be offered to the community due to lack of funding.
- <u>Financial Fiscal impact if not approved</u> The staff and programs are financially dependent upon these funds. If not approved, the programs will be unable to operate under the current structure.

This decrease is the result of an unanticipated increase in the number of mosquito control programs participating in

- **Duration** October 1, 2022 through September 30, 2023
- <u>Benefits to Martin County</u> Enables the Mosquito Control Division to purchase chemicals used for arthropod control.
- Cost to Martin County The agreement requires matching with local funds of 25%, in the amount of \$19,644.64 which will come from the Division's operating budget. Staff time to process grant requirements.

The grant requires at least a 50% match through cash or third-party in-kind contribution to be shown on each payment request. \$1,500,000 of the required match is currently budgeted in the Florida Power and Light (FPL) Franchise Fund and the balance will be budgeted in the State Revolving Fund (SRF) Loan Construction Fund after the final assessment resolution for Coral Gardens Septic to Sewer project is approved.
- New/Renewal/Modified New
- <u>Duration</u> Begins upon agreement execution through 12/31/26
- Benefits to Martin County Funding will reduce the cost of assessment to benefiting property owners and result in a completed project that will significantly reduce nitrogen and phosphorous concentrations to the Indian River Lagoon (IRL).
- <u>Cost to Martin County</u> Required match of 50% (\$8,000,000) to be funded by FPL Franchise Fees, SRF Loan Construction Fund, and assessments. Staff time to administer the grant.

- Benefits to Martin County Loan Agreement provides for 1.34% interest loan over 20-year amortization in lieu of conventional financing presently at a much higher interest rate and much shorter amortization.
- <u>Cost to Martin County</u> This State Revolving Fund loan in the amount of \$20,000,000 is an obligation to Martin County which will be repaid through non-ad valorem special assessments and staff time to administer the loan.

9. ADJUSTMENT TO THE FISCAL YEAR 2023 BUDGET

The Office of Management and Budget (OMB) is requesting approval to modify the FY23 budget in accordance with Generally Accepted Accounting Principles (GAAP). These adjustments are necessary to align revenues and expenditures to reflect activities as well as make corrections, budgeted transfers, and budget transfers from reserves as follows:

A. <u>BUDGET RESOLUTION TO ADJUST FY23 BUDGET DUE TO POST-FUND BALANCE ACCOUNTING ENTRIES MADE BY THE FINANCE DEPARTMENT:</u>

After the FY23 Fund Balance adjustments were reconciled, the Clerk's Finance Department made post-FY22 year-end adjustments to retainage payable accounts that are necessary to accurately reflect in the FY23 adjusted budget balance. The Office of Management and Budget requests approval of the Budget Resolution to adjust these budgets accordingly.

B. BUDGET RESOLUTION TO ALLOCATE ADDITIONAL REVENUES FOR SEASIDE CAFE:

The Seaside Café continues to outperform revenue estimates and sales have been greater than expected. The increase in revenue will require an increase in operating costs.

Due to the continued high performance, it is anticipated that the budgeted revenue collection reflected in the FY23 budget will be exceeded by approximately \$350,000. The Office of Management and Budget is requesting a Budget Resolution to appropriate the anticipated additional revenues into the FY23 budget.

(1) Modification of the Meters Replacement Project CIP Sheet:

The Utilities and Solid Waste Department is requesting the Board's approval to modify the CIP sheet for the Automatic Read (AMR) Meters Replacement Project and to transfer \$495,000 from capital reserves to the AMR CIP budget line item for the order of meters and associated expenses in advance for next fiscal year work. According to the meters' vendor, there are supply chain problems and long waiting times of up to 11 months for certain types of meters. Funding is needed now to open purchase orders for next year's work.

reserves to the Seagate Harbor budget line item. This project was originally budgeted at \$475,000 in fiscal year 2021. The project included three phases. The first two phases are completed and included building modifications and valve replacements. The third phase includes the replacement of the vacuum pumps and associated electrical equipment in the vacuum station. The cost for the first two phases came in higher than what was originally anticipated, and prices have dramatically increased since this project was originally budgeted.
