1. PERMISSION TO ACCEPT THE WILLOUGHBY CREEK STORMWATER QUALITY IMPROVEMENT PROJECT ENVIRONMENTAL PROTECTION AGENCY / FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION SECTION 319 (H) AND TOTAL MAXIMUM DAILY LOAD (TMDL) WATER QUALITY RESTORATION GRANT, CONTRACT NO. NS035

- <u>Agreement/Contract drafted by</u> State of Florida Department of Environmental Protection
- <u>Parties to the Agreement/Contract</u> State of Florida Department of Environmental Protection and Martin County Board of County Commissioners.
- <u>Purpose of the Agreement/Contract</u> Grant award of \$1,900,000 for funding of construction, educational components and water quality monitoring associated with the Willoughby Creek Stormwater Quality project.
- <u>New/Renewal/Modified</u> This is a new contract that was applied for in April 2016.
- **Duration** Upon execution of both parties through March 31, 2022
- Benefits to Martin County Grant award of \$1,900,000 to partially fund the
 project that will provide water quality benefits to the St. Lucie River and Estuary.
 This project will provide credits for the County's requirements to comply with
 TMDL and BMAP mandates.
- Cost to Martin County This grant has a 79/21 match requirement of \$500,000. The County funds, in the amount of \$500,000, have been planned for through the CIP process and budgeted in the Stormwater MSTU and Ad Valorem.

ALTERNATIVE ACTION:

- <u>Programmatic Implication if not approved</u> The project is not constructed and the County's requirement to meet the mandated TMDL / BMAP program is jeopardized.
- <u>Financial Fiscal impact if not approved</u> The Stormwater MSTU & Ad Valorem will retain the \$500,000 until approval is granted.

- <u>Purpose of the Agreement/Contract</u> Grant award of \$99,720 for funding for rental assistance to qualified participants.
- New/Renewal/Modified This is a renewal contract that renews annually.
- **Duration**: 12 months
- Benefits to Martin County Shelter Plus Care grants are essentially a portable Section 8 voucher that allows the targeted individuals to select housing and receive a subsidy from the Federal government. Supportive services, provided by area service providers designed to ameliorate program participant identified disabilities, is counted as the local match for the grant. The Health and Human Services Program manages the grant(s) and is responsible for ongoing assessment of the rental assistance and supportive services required by the participants in the Program; to assure the adequate supportive services to the participants in the Program; and is responsible for the overall administration of the grant including record keeping and reports required by HUD.
- Cost to Martin County Staff time to administer the grant.

ALTERNATIVE ACTION:

- <u>Programmatic Implication if not approved</u> Health and Human Services staff will not be able to provide rental assistance and supportive services to targeted disabled population.
- Financial Fiscal impact if not approved NONE

Most importantly, this grant provides program needs to ensure the safety and protection of residents.
- Cost to Martin County: Staff time to administer the grant.

ALTERNATIVE ACTION:

- Programmatic Implication if not approved This type of training plays an
 essential role in the management of, and response to, local emergencies, and
 provides students with the professional development support to obtain the
 knowledge and skills needed to perform effectively as a team under stressful,
 dynamic conditions. If not approved, this training would not be available to first
 responders and Emergency Operations Center personnel.
- **Financial Fiscal Impact if not approved-** Funds would not be available for this program.
