**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS  
OF MARTIN COUNTY, FLORIDA, RELATING TO THE  
ACCEPTANCE OF SE KARIN STREET IN THE PLAT OF PAPAYA  
VILLAGE INTO THE COUNTY ROAD INVENTORY**

**WHEREAS**, the Board of County Commissioners has authorizes 211 linear feet of unopened Right-of-Way to be opened for roadway connection, constructed in accordance to Martin County Standards for Road and Site Construction, and accepted into the Martin County Road Inventory;

**WHEREAS**, the plat of Papaya Village dedicated the road right-of-way to the perpetual use of the public; and

**WHEREAS**, staff is authorized to determine that this request complies with the requirements for opening roads as set forth in the Land Development Regulations, Martin County Code; and

**WHEREAS**, Martin County Engineering Department agrees to construct the roadway improvements in full compliance with the permitted construction plans and specifications under the supervision of its Engineer and upon completion, that Engineer shall furnish an Engineer's Certification of Construction Completion to the County Engineer for acceptance; and

**WHEREAS**, all conditions precedent to the acceptance of 211 linear feet of road right-of-way into the Martin County Road Inventory will be met or fulfilled by the Martin County Engineering Department; and

**WHEREAS**, upon completion of the construction, the Board of County Commissioners will maintain said roadway and stormwater management; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY, FLORIDA, AS FOLLOWS:**

Upon the County Engineer's acceptance of the Certification of Construction Completion, the 211 linear feet of SE Karin is hereby accepted into the Martin County Road Inventory, as publicly owned and publicly maintained road right-of-way.
