2019 PROPOSED LEGISLATIVE PRIORITIES

Septic to Sewer Funding

REQUEST funding for the completion of Martin County's Connect to Protect Golden Gate Septic to Sewer Conversion Project.

East Fork Creek Stormwater Treatment Area

REQUEST funding for the construction of a water quality alternative treatment project. The BCC REQUESTS that any appropriation identified in the General Appropriations Act.

Biosolids

SUPPORT establishing a pilot project program for funding new state of the art wastewater technologies to improve recovery and afford more efficient use of human wastewater biosolids.

US 27 Multimodal Corridor

SUPPORT FDOT's efforts to reduce freight traffic from the congested coastal corridor of South Florida by relocating rail and highway freight to a more westerly corridor to expand business opportunities for the entire area and enhance the overall quality of life by providing better highway travel and less local traffic congestion for residents and visitors.

Community Redevelopment Agency Statutory Authority

SUPPORT retaining current language found in Chapter 163, Part III, Florida Statutes, creating mechanisms for cities and counties to negotiate, establish, operate and fund Community Redevelopment Agencies and OPPOSE legislation aimed at limiting, dismantling or reducing funding for Community Redevelopment Agencies.

Beach Funding

SUPPORT a dedicated annual funding source of a minimum of \$50 million from the Land Acquisition Trust Fund, the recognized funding source for the beach program, or any other funding sources identified by the legislature for statewide beach nourishment and inlet management projects to replace the historical doc stamp allocation and trust fund.

Purchasing PalMar

SUPPORT state funding for PalMar land acquisition as a part of the Comprehensive Everglades Restoration Effort.

Arts Council Funding

SUPPORT the restoration of legislative funding for arts and culture in Florida
