**A RESOLUTION PERTAINING TO THE APPOINTMENT OF MEMBERS TO  
NEIGHBORHOOD ADVISORY COMMITTEES**

**WHEREAS**, the Martin County Board of County Commissioners, pursuant to Martin County Code Section 7 1/3-5, as amended by Section 39.4.A. provided for the creation of Neighborhood Advisory Committees; and the required qualifications of Neighborhood Advisory Committee members; and

**WHEREAS**, Section 39.4.A.1.b., Martin County Code, sets forth the number of members of Neighborhood Advisory Committees as five to nine members; and

**WHEREAS**, by Resolution 18-9.29, the Board of County Commissioners established the number of members of each Neighborhood Advisory Committee; and

**WHEREAS**, by Resolution 18-11.18, the Board of County Commissioners amended the number of members of the Port Salerno Neighborhood Advisory Committee; and

**WHEREAS**, in accordance therewith, the Neighborhood Advisory Committees were established; and

**WHEREAS**, the Board of County Commissioners solicited applications and has selected the individuals who meet the described qualifications and are aware of the purpose, duties, and responsibilities of service on the Neighborhood Advisory Committee.
