1. This Fine Reduction Stipulation and Agreed Recommended Order involves a parcel located at 9744 SE Hidden Court, Hobe Sound, Martin County, Florida and further described as:

Lot 11, of HOBE PINES, according to the Plat thereof, as recorded in Plat Book 7, at Page 89, of the Public Records of Martin County, Florida.

- 2. On July 16, 2014, the Code Enforcement Magistrate entered an Order Finding Violation against Shawn Ranger for violation of Section 67.201.B Nuisance Declared: Trash, Etc. under General Ordinances, Martin County. An Affidavit of Compliance with fines was issued on October 23, 2014 in the amount of \$3,975.00 recorded in Order Book 2748 Page 825.
- 3. Staff has determined that a lien reduction is warranted. The Respondent has offered to pay \$575.00 to resolve the outstanding fine which has accrued. The current value of the property is listed at \$160,920.00 per the Martin County Property Appraiser's website.
- 4. The parties represent, under penalty of perjury that that they have read this Stipulation; that they have full authority to enter into this Stipulation; that the facts contained herein are the truth, the whole truth and nothing but the truth; and that they are signing this agreement freely and voluntarily and are under no duress to execute it.
