**RESOLUTION INCREASING THE OPC RIPPLE STORMWATER WATER QUALITY FUND REVENUES AND APPROPRIATIONS**

- WHEREAS,** A grant has been awarded for \$429,000 and Martin County is required to provide a match for \$286,000, which is currently budgeted within the Ecosystem Capital Improvement Plan; and
- WHEREAS,** Appropriations of unanticipated funds must be appropriated in accordance with Section 129.06(2)(d), Fla. Stat.; and
