The hearing will be conducted beginning at 9:00 AM., or as soon thereafter as the following item may be heard. The title of the proposed ordinance is:

**AN ORDINANCE OF MARTIN COUNTY, FLORIDA, CREATING ARTICLE 12, REDEVELOPMENT CODE, DIVISION 1, GENERAL, AND DIVISION 2, JENSEN BEACH COMMUNITY REDEVELOPMENT CODE, LAND DEVELOPMENT REGULATIONS, MARTIN COUNTY CODE; DELETING SECTION 3.261, JENSEN BEACH COMMUNITY REDEVELOPMENT AREA; AND MAKING AMENDMENTS TO OTHER ARTICLES, DIVISIONS OR SECTIONS OF THE LAND DEVELOPMENT REGULATIONS AS NECESSARY TO MAINTAIN INTERNAL CONSISTENCY; PROVIDING FOR APPLICABILITY, CONFLICTING PROVISIONS, SEVERABILITY, FILING WITH THE DEPARTMENT OF STATE, CODIFICATION, AND AN EFFECTIVE DATE**
