1. CALL TO ORDER

The meeting was called to order at 3:00 PM.

2. APPROVAL OF MINUTES - January 17, 2019

*Shaun Kelly moved approval of minutes with correction of typographical error on page one. Polly Campenni seconded the motion. **Motion pass unanimously.

4. OLD BUSINESS

A. Review and discuss updated draft of Martin County Animal Ordinance (Chapter 9) Ruth Holmes started review of revised draft and asked George Stokus to lead discussion. Mr. Stokus reviewed each section with outstanding questions. Members provided their comments and recommendations for final wording revisions.

B. TNVR Program Update

Deputy Sheriff Weiss provided a TNVR update. The number of cats has leveled off to about six to twelve per week. Up to 299 cats since program began in December 2017.

Dr. Rex Sentell asked D/S Weiss for an update on Animal Services. D/S Weiss shared the MCSO is currently hiring two animal services officers.

5. NEW BUSINESS

A. Selection of Chair and Vice Chair

Rita Nelson nominated Dr. Rex Sentell to continue as Chair. *Rita Nelson moved to select Dr. Sentell as Chair. Shaun Kelly seconded the motion.

**Motion passed unanimously.

Polly Campenni nominated Dr. Richard Smith to continue as Vice Chair. *Polly Campenni moved to select Dr. Smith as Vice Chair. Shaun Kelly seconded the motion.

**Motion passed unanimously.

B. Meeting schedule

George Stokus thanked members for their work to complete the revision of Martin County's animal ordinance. Now that this work is complete, he suggested changing meeting schedule from quarterly meetings to two meetings per year. Mr. Stokus explained we can change schedule at any time and call a special meeting if needed.
