**A RESOLUTION AUTHORIZING TERMINATION OF TWO MAINTENANCE
MEMORANDUM OF AGREEMENT FOR THE MAINTENANCE OF
ENHANCED LANDSCAPING FOR STATE ROAD 76 (S KANNER HIGHWAY)
FROM THE I-95 INTERCHANGE TO SE COVE ROAD AND AUTHORIZING
THE EXECUTION OF A LANDSCAPE MAINTENANCE MEMORANDUM OF
AGREEMENT TERMINATIONS**

WHEREAS, the Board of County Commissioners of Martin County (Board), entered into a Maintenance Memorandum of Agreement (MMOA) with the Florida Department of Transportation (FDOT) on September 9, 1998 to maintain enhanced landscaping and irrigation installed by FDOT on SR-76 (S Kanner Highway) from Interstate I-95 to SE Cove Road (WPI No. 4119110); and

WHEREAS, the Board entered into a MMOA with the FDOT on June 9, 2004 to maintain additional enhanced landscaping and irrigation installed by FDOT at the intersection of SR-76 (S Kanner Highway) and SW Lost River Road (FM No. 230010); and

WHEREAS, by entering into the MMOAs, the Board accepted responsibility to maintain the enhanced landscaping and irrigation identified in the two MMOAs; and

WHEREAS, the FDOT removed the enhanced landscaping associated with the two MMOAs during I-95 interchange improvement project in 2017, which abrogated the need for the County to provide enhanced landscape maintenance in these locations; and

WHEREAS, the FDOT has requested the Board agree to terminate the two MMOAs through a Landscape Maintenance Memorandum of Agreement Terminations.

**NOW, THEREFORE, BE IT RESOLVED BY THE MARTIN COUNTY BOARD OF
COUNTY COMMISSIONERS THAT:**

1. Martin County hereby agrees to terminate the MMOA dated September 9, 1998 (WPI No. 4119110) and the MMOA dated June 9, 2004 (FM No. 230010) related to the enhanced landscaping and irrigation on SR-76 (S Kanner Highway); and
2. The Board hereby authorizes the Chair to execute the Landscape Maintenance Memorandum of Agreement Terminations.
