**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
OF MARTIN COUNTY, FLORIDA, RELATING TO THE
ACCEPTANCE OF A PORTION OF SW 54th AVENUE AND A
PORTION OF SW 66th STREET IN THE PLAT OF PALM CITY
FARMS INTO THE COUNTY ROAD INVENTORY**

WHEREAS, a Road Opening Permit application was submitted to open a portion of SW 66th Street and a portion of SW 54th Avenue; and,

WHEREAS, the Board of County Commissioners has authorized staff to determine that this request complies with the requirements for opening roads as set forth in the Land Development Regulations, Martin County Code; and

WHEREAS, all conditions precedent to the acceptance of 2,750 linear feet of road rights-of-way (pursuant to the plat of Palm City Farms, as recorded in the Plat Book 6, Page 42 of the public records of Martin County) into the Martin County Road Inventory will be met or fulfilled prior to the issuance of the Road Opening Permit; and

WHEREAS, the plat of Palm City Farms dedicated the road right-of-way to the public; and

WHEREAS, the applicant agrees to construct the roadway improvements in full compliance with the permitted construction plans and specifications under the supervision of applicant's Engineer and upon completion, the applicant's Engineer shall furnish an Engineer's Certification of Construction Completion to the County Engineer for acceptance; and

WHEREAS, the Board of County Commissioners agrees to maintain the proposed roads, bridle paths, and stormwater management systems within the rights-of-way following a one-year maintenance period upon completion of the construction of said roads, bridle paths, and stormwater management systems.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY, FLORIDA, AS FOLLOWS:

Upon the County Engineer's acceptance of the Certification of Construction Completion, the Board of County Commissioners of Martin County, Florida hereby accepts into the Martin County Road Inventory 1,400 linear feet of SW 54th Avenue and 1,350 linear feet of SW 66th Street, as publically owned and publically maintained road rights-of-way.
