RIGHT-OF-WAY DEED

THE NORTH 25.00 FEET OF THE SOUTH ONE-HALF(1/2) OF THE NORTH ONE-HALF(1/2) OF THE SOUTHWEST ONE-QUARTER(1/4) OF THE SOUTHWEST ONE-QUARTER(1/4) OF SECTION 22, TOWNSHIP 37 SOUTH, RANGE 41 EAST, MARTIN COUNTY, FLORIDA.

TOGETHER WITH THE FOLLOWING DESCRIBED PARCEL OF LAND:




