What is the Capital Improvement Plan?

A Capital Improvement
Plan (CIP) is a multi-year
planning instrument used
to identify needs and
financing sources for
public infrastructure
maintenance and
improvements.

Martin County provides necessary and desired public services to the community and the purpose of the CIP is to facilitate the orderly planning for constructing, maintaining, and protecting the infrastructure system that is utilized for those public services.

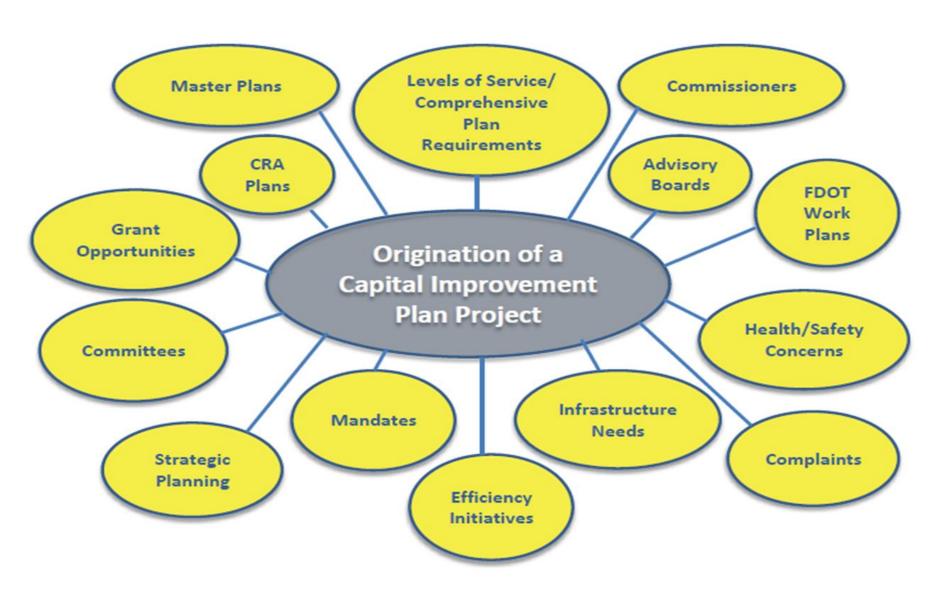
Revenue Planning

Per the Martin County Comprehensive Growth Management Plan: 14.5.B.

• Costs and revenues by type of public facility. In the following sheets, each type of public facility is listed and the major costs and sources of revenue are summarized for the October 1, 2020 - September 30, 2025 time period. This Schedule of Capital Improvements (the first 5 years of the 10-year CIP) is 100 percent financed by revenue sources that are available to the County under current law and is therefore financially feasible, as required by the Florida Administrative Code. There is no "unfunded" portion of the Schedule of Capital Improvements.

Typical Capital Improvement Plan Process

Dec

- Department Director creates CIP sheet
- Department Director prioritizes projects

Feb/ March

- CIP sheet is submitted to OMB for funding
- CIP sheet is reviewed by staff and County Administration

Anril

- CIP is presented to the Board for discussion and approval
- If approved, the CIP project is included in the tentative budget

Julv

• The Board reviews the tentative annual budget and sets tentative millage rate

Sept

 The Board adopts the annual budget for fiscal year beginning October 1 via Public Hearings



Presentation of the FY21 CIP Projects

Enterprise fee-funded projects

- These project budgets have been funded by accumulated fees in order to fulfill capital requirement needs.
 - Utilities and Solid Waste
 - Airport

Non-Enterprise feefunded projects

• The departments will present projects with recommendations regarding grant funding opportunities and time sensitivity

Projects that are approved with the FY21 CIP will commence on a deferred schedule

- Projects will not begin until January 1, 2021 (vs the regular October 1, 2020 date) to ensure funding availability
 - Ad Valorem collections from the Tax Collector's Office
 - Revenue trend impacts in non-ad valorem funding sources



CIP Adjustments due to COVID-19

Due to uncertainties related to revenue planning as a result of the COVID-19 pandemic, staff re-evaluated FY21 Capital Improvement project needs and made adjustments as follows:

Tier 1:

projects, that if not funded, could be detrimental to the health, safety and welfare of County operations and services

Tier 2:

projects that could endure reduced funding temporarily to lessen the impacts

Tier 3:

projects that have been deferred until revenue projections stabilize and/or grant funding is likely due to the nature of the project

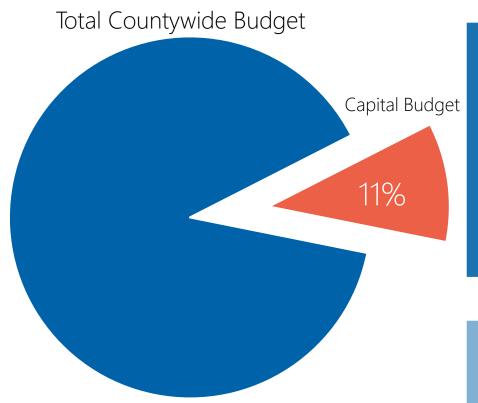
