

**MUTUAL TERMINATION OF INTERLOCAL AGREEMENTS
FOR HIDDEN OAKS MIDDLE SCHOOL
AND HOBE SOUND ELEMENTARY SCHOOL
BETWEEN MARTIN COUNTY BOARD OF COUNTY COMMISSIONERS AND
THE SCHOOL BOARD OF MARTIN COUNTY, FLORIDA**

This MUTUAL TERMINATION ("TERMINATION") dated _____, 2020, is made by and between THE MARTIN COUNTY BOARD OF COUNTY COMMISSIONERS ("COUNTY") and THE SCHOOL BOARD OF MARTIN COUNTY, FLORIDA ("SCHOOL BOARD").

WITNESSETH:

WHEREAS, on June 16, 1992, the COUNTY and the SCHOOL BOARD entered into an Interlocal Agreement regarding the track, basketball court and concession/restroom/storage facilities with basic amenities at Hidden Oaks Middle School, which was amended by the First Amendment to Interlocal Agreement dated June 18, 2008, to add the field facilities (the "Hidden Oaks Agreement"); and

WHEREAS, on July 23, 1992, the COUNTY, the SCHOOL BOARD, and the Hobe Sound PTA entered into an Interlocal Agreement regarding the playground facilities known as "Kids Kingdom" at Hobe Sound Elementary School, recorded in Official Records Book 0977, Page 1966, of the public records of Martin County, Florida (the "Hobe Sound Agreement"); and

WHEREAS, use of these facilities by the public through the County's Parks and Recreation Department reservations has been minimal; and

WHEREAS, the COUNTY and the SCHOOL BOARD no longer wish to be bound by the terms and conditions set forth in the Hidden Oaks Agreement and the Hobe Sound Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and benefits, the parties do hereby agree as follows:

COUNTY and SCHOOL BOARD hereby mutually terminate their Interlocal Agreements effective on the date of this TERMINATION, as follows:

1. June 16, 1992, Interlocal Agreement for Hidden Oaks Middle School, as amended on June 18, 2008.
2. July 23, 1992, Interlocal Agreement for Hobe Sound Elementary School.

IN WITNESS WHEREOF, the parties hereto have executed this TERMINATION effective on the date written above.
