STIPULATION AND AGREED FINAL ORDER

The Petitioner and the Respondent hereby freely stipulate and agree to the following:

- 1. Respondent is the owner of the property located at 18505 SE Clubhouse Drive, Jupiter, in Martin County, Florida and further described in Exhibit A attached hereto.
- 2. On June 11, 2018, an inspection of the property was performed by the Martin County Growth Management Department staff, and at that time, and continuing until March 20, 2019, the Respondent did maintain conditions on the property as cited in the Notice of Violation in this case.
- 3. Respondent freely admits the violation of the Code as cited.

4. **VIOLATION:**

Construction activity associated with the Jonathan's Landing Golf Club Restoration project has resulted in negative impacts to wetlands and to platted preservation areas.

CODE SECTIONS:

SECTION 4.1.B.Wetlands applicability

All wetlands in unincorporated Martin County shall be protected. Freshwater wetlands and estuarine wetlands shall be protected and regulated pursuant to sections 4.1., 4.2., 4.3., 4.6., and 4.7., within the Land Development Regulations (LDR) and Objective 9.1G., Martin County Comprehensive Growth Management Plan (Comprehensive Plan). If there is any conflict between Article 4, Division 1 and Objective 9.1G. Comprehensive Plan, the Comprehensive Plan shall control.

SECTION 4.7.A.2. Correction of violation upon notice of violation.

Correction of a violation of applicable regulations of this division shall consist of the following:

Where activities in violation of the Comprehensive Plan, the Code of Ordinances, the LDR, an approved PAMP, or an approved development order have altered any wetland area so that all or part of the original area no longer meets the definition of a wetland or has negatively impacted a wetland, restoration shall be required within 90 days after receiving a notice of violation. This requirement shall include submittal of a PAMP application for the subject property including an approved restoration plan, a commitment for installation and maintenance of plant materials for environmental restoration and a minimum two-year letter of credit, or other acceptable financial alternative, to assure the successful restoration of the particular violation.

- 5. Respondent has met all compliance requirements outlined in the notice of violation except for submittal of a preserve area management plan (PAMP).
- 6. Respondent has requested additional time to obtain the PAMP while it proceeds with an application for a revised final site plan and plat.
- 7. Petitioner is amenable to the request for additional time subject to the following compliance requirements.
- 8. COMPLIANCE REQUIREMENTS AND TIMETABLE:
 - A. By May 1, 2019, Respondent shall submit the required application for the revised final site plan for the Jonathan's Landing Golf Club.
 - B. Respondent shall proceed in good faith with the revised final site plan application and receive approval by March 1, 2020.
 - C. If Respondent does not receive revised final site plan approval by March 1, 2020, Respondent shall submit the requested PAMP by March 31, 2020. If Respondent withdraws the application, Respondent shall submit the PAMP within (30) days of the date of withdrawal of the application.
- 9. If Respondent fails to comply with the Compliance Requirements and Timetable, the Respondent agrees to the levy of a fine in the amount of \$500.00 per day thereafter, for each and every day of non-compliance, plus all administrative costs in enforcing the action.
- 10. Pursuant to Chapter 162, Florida Statutes, no further hearing shall be required for the entry of a fine and costs. In addition, all fines and costs become liens on the property of the Respondent.
- 11. Respondent agrees to pay \$575.00 in administrative costs, on or before March 20, 2019.

AMENDMENT NO. 2 TO THE OLD TRAIL DECLARATION OF COVENANTS AND RESTRICTIONS

WHEREAS, THE OLD TRAIL DECLARATION OF COVENANTS AND RESTRICTIONS and Exhibits attached thereto are recorded in Official Record Book 703, Pages 1641 through 1800, inclusive, as amended by Amendment No. 1 thereto, as recorded in Official Record Book 756, Pages 361 and 362, and as further amended by the Supplement to Old Trail Declaration of Covenants and Restrictions, as recorded in Official Record Book 813, Pages 1932 through 1938, inclusive, all of the Public Records of Martin County, Florida (hereinafter, collectively, the "Declaration"); and

WHEREAS, Article XII of the Declaration, Amendment, provides that the Declaration may be amended by instruments in writing, recorded in the Public Records of Martin County, Florida, and approved by the affirmative vote of two-thirds (2/3) of the Board of Directors of Old Trail Homeowners Association, Inc., prior to the first meeting of the members; and

WHEREAS, the first meeting of the members of the Old Trail Homeowners Association, Inc. has not yet taken place; and

WHEREAS, by execution hereof by two-thirds of its members, the Board of Directors of Old Trail Homeowners Association, Inc. does hereby acknowledge its approval of the following amendments.

NOW, THEREFORE, the OLD TRAIL DECLARATION OF COVENANTS AND RESTRICTIONS is hereby amended as follows:

1. The third paragraph of Article VII, Section $\rm H(1)$ is hereby deleted in its entirety and the following is substituted in lieu thereof:

Common Expenses shall also include assessments made by the RCPOA for the payment of its expenses, pursuant to the Ranch Colony Restrictions. As described in Article VI herein, such assessments may only be levied against certain property within Old Trail; however, said assessments shall be payable by all of the owners within Old Trail through the Corporation, as a common expense. If

permitted under the Ranch Colony Restrictions, the individual Lot Owners, the Golf Course Owner, and the Corporation shall each be members of the RCPOA. However, the Corporation shall collect the monies due for such assessments as Common Expenses of the Corporation and shall be responsible for remitting such monies to the RCPOA. Assessments made under the Ranch Colony Restrictions are for the payment of expenses of RCPOA for the maintenance of private streets and drives and drainage facilities, improvements to and maintenance of common facilities, costs of operation of the RCPOA, insurance premiums, and legal and accounting fees, as more fully and completely described in the Ranch Colony Restrictions.

- 2. Article VII, Section I(1) is hereby deleted and the following is substituted in lieu thereof:
 - I. The amount of assessments shall be determined as follows:
 - The amount of general assessments shall be determined as follows: the total Common Expenses ("Total Corporation Expenses") shall be comprised of the Corporation's expenses and the expenses assessed against the Corporation by the Ranch Colony Area Land Owners Association, Inc. and the RCPOA. The assessment on the Golf Course Property ("Total Golf Course Assessment") will be determined by multiplying the Total Corporation Expenses by 73%, which represents a fraction, the numerator of which is the number of acres comprising the Golf Course Property, and the denominator of which is the total number of acres in OLD TRAIL. The assessment against each Lot shall be equal for all Lots and shall be determined by subtracting the amount of the Total Golf Course Assessment from the Corporation Expenses and dividing the result by 74, the total number of Lots. The formulas are as follows:

(a) X = Corporation Expenses

Y = RCPOA Assessment

Z = Ranch Colony Area Land Owners
 Association, Inc. Assessment

X+Y+Z = Total Corporation Expenses

(b) Total Golf Course Assessment =

73% x Total Corporate Expenses

- (c) Lot Assessment = (Total Corporation Expenses Total Golf Course Assessment) + 74
- 3. Article VIII, Section L is hereby deleted in its entirety and the following is substituted in lieu thereof:

L. <u>Preservation Areas</u>. The owners of Lots 7, 8, 9, 24, 25, 26, 27, 38, 39, 40, 45, 46, 47, 48, 53, 54, 57 and 58, which Lots abut wetland and cypress preservation areas, as shown on the Plat, may only make alterations within the twenty-five (25') foot setbacks relative to such preservation areas which are consistent with a management plan approved by Martin County, Florida.

The Preservation Easements and the Preserve Area Parcel G as identified on the Plat shall be maintained in accordance with the preservation plan shown on the Final Development Plan for Phase 2 on file with, and approved by, Martin County and cannot be altered without the prior approval by the Martin County Board of County Commissioners.

4. Exhibit C to the Declaration is hereby deleted and the attached Exhibit C is hereby substituted in its place and stead.

Except for amendments hereinabove set forth, the recorded OLD TRAIL DECLARATION OF COVENANTS AND RESTRICTIONS, as previously amended, and all of its terms, conditions, provisions, agreements and covenants, shall remain in full force and effect.

Further, in order to avoid any misunderstanding with respect to the number of pages comprising Exhibit M of the Old Trail Declaration of Covenants and Restrictions, being the last exhibit

the Board of Directors of Old Trail Homeowners Association, Inc. hereby declares that said Exhibit M consists of a total of five (5) pages and that the last page of said Declaration, including all exhibits thereto, is recorded at Page 1800 of Official Record Book 703 of the Public Records of Martin County, Florida.
