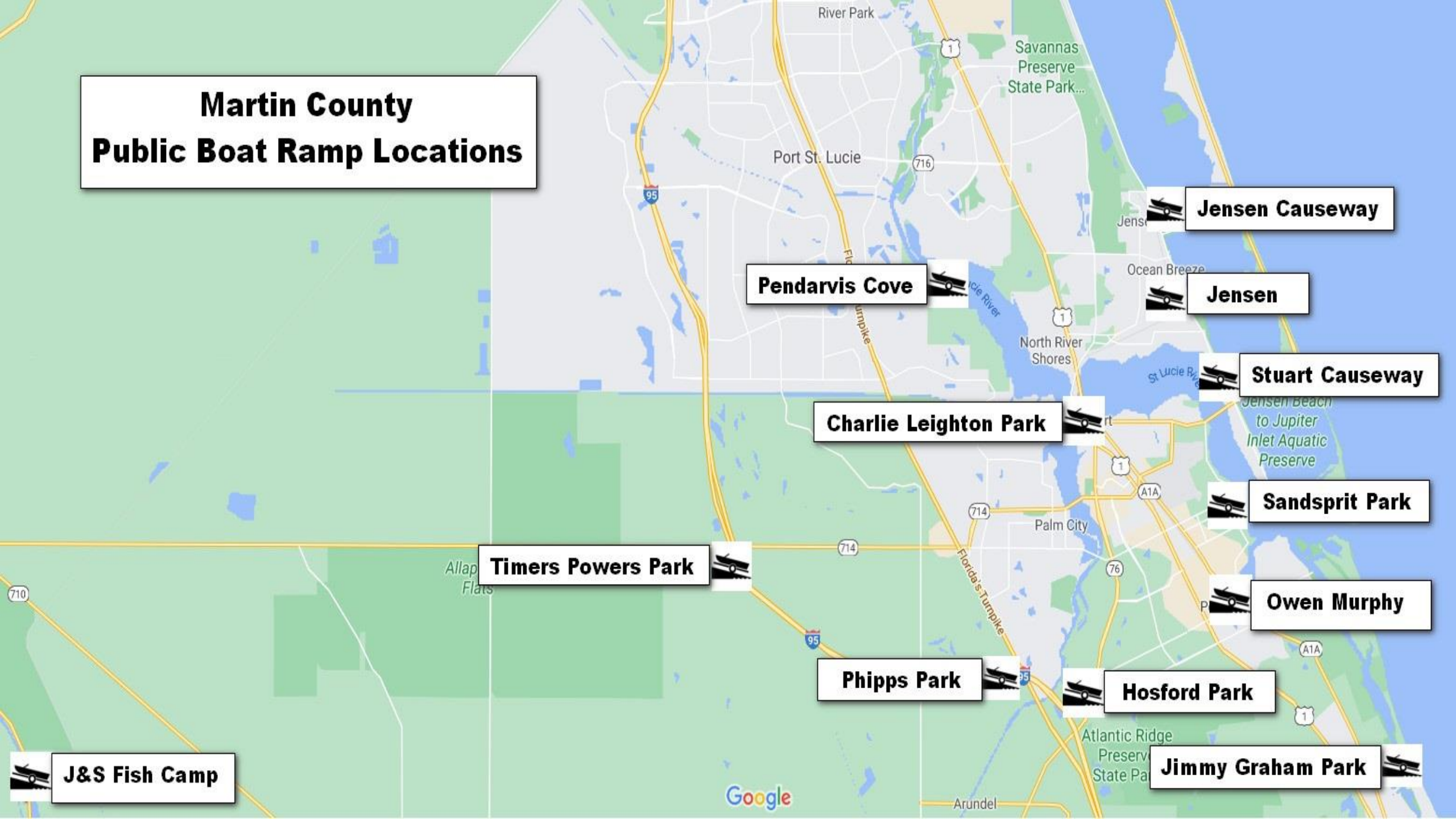

COUNTY BOAT RAMP GOALS

- ✓ Design for resiliency (king tides, storms and sea level rise)
- ✓ Design and construct for long term life cycle sustainability
- ✓ Evaluate adjacent boat ramp parking
- ✓ Replace fixed docks with floating docks where logical
- ✓ Design to address larger recreational boats and their impact on ramps (power loading, size, approach, etc.)
- ✓ Implement ADA design elements
- ✓ Apply for matching waterway assistance grants (Florida Inland Navigation District, Florida Boaters Improvement Program, etc.)

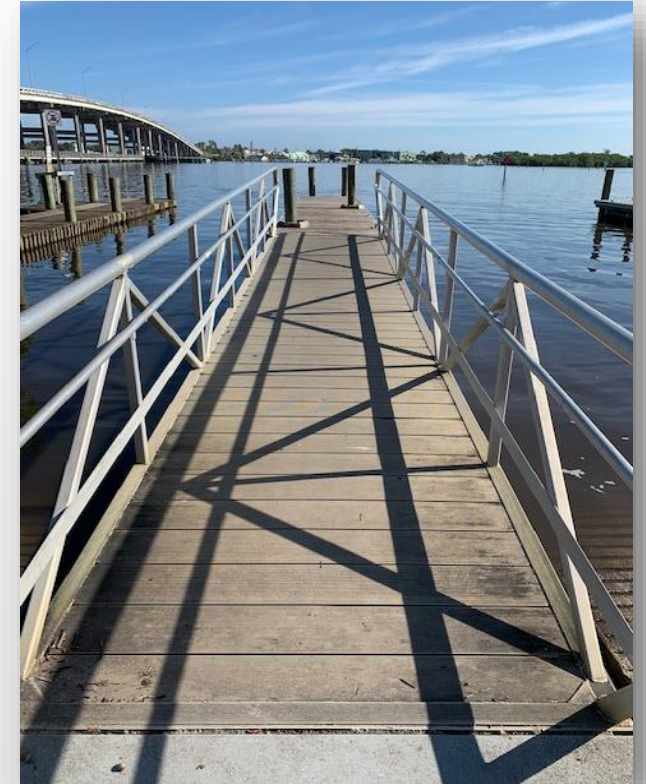
