 - Requestor Martin County Fire Prevention Division

 - <u>Project Description</u> –The objectives of the SAFER Program are to provide critically needed resources to carry out fire prevention education and training, fire code enforcement, fire/arson investigation, firefighter safety, health programming, prevention efforts, and research and development.
 - Requested Grant Award \$100,000
 - <u>Budgetary Impact</u> Grant Match of \$5,000, budgeted in the Fire Prevention operational budget.

- Requestor Fire Rescue Department.
- **Granting Agency** U.S. Department of Homeland Security/FEMA.
- <u>Project Description</u> The Martin County Fire Rescue Department is seeking funding to purchase critically needed resources to carry out fire prevention education and training aimed to enhance the Community Risk Reduction programs already in place.
- Requested Grant award \$100,000.
- **Budgetary Impact** Total grant match of 5% or \$5,000.
- Annual Operating Cost Staff time for grant administration.

3. PERMISSION TO APPLY FOR THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) ASSISTANCE TO FIREFIGHTERS GRANT (AFG) FOR EQUIPMENT

- **Requestor** Fire Rescue Department
- Granting Agency U.S. Department of Homeland Security/FEMA
- Project Description The Martin County Fire Rescue Department is seeking to add 15 power-loading stretcher systems to outfit the entire fleet of frontline ambulances. Power-loading cot fastener systems help to prevent debilitating back, shoulder, and other muscular injuries. The power loaders are ergonomically designed to reduce operator and patient injuries by hydraulically lifting patients weighing up to 700 lbs. Power lift systems improve operator and patient safety by supporting the cot throughout the entire loading and unloading process. Emergency Medical Service providers that have implemented lifting and loading systems have witnessed significant reductions in work-related injuries. Workplace injury reduction equates to tremendous cost savings. The cumulative medical costs incurred by the employer associated with a single career-ending back injury or an injured patient can be staggering.
- Requested Grant award \$380,720
- <u>Budgetary Impact</u> Total grant match of \$38,072 which is available in the Fire Rescue Capital Improvement Plan Fixed Asset Replacement Budget (FARB).
- Annual Operating Cost Staff time for grant administration.

Programmatic Implication if not approved – There is a higher potential risk of

an injury occurring to either the employee or patient during the on and offboard procedure from the EMS transport unit.

• <u>Financial Fiscal impact if not approved</u> – To outfit the entire transport fleet without the grant assistance would cost \$380,720.

 - **Granting Agency** Florida Department of Transportation
 - <u>Project Description</u> Citrus Boulevard between CR 714 and the St. Lucie County Line, has beginning signs of pavement delamination which will require resurfacing as the roadway paving life span is 20 years. Additional scope items to include new signage and signalization and improved drainage.
 - Requested Grant Award The total estimated project is \$2,944,304 (\$2,208,228 grant funds/\$736,076 local funds)
 - <u>Budgetary Impact</u> SCOP grants require a 75%-25% fund match; \$736,076 to be funded with FY 27 Capital Improvement Funds (CIP).
 - Annual Operating Cost
 - Annual maintenance cost is estimated to be \$3,000 per year.
 - Staffs time to administer the grant.

 <u>Project Description</u> – The existing Arundle Bridge is a 450' long high roadway bridge over the C-44 Canal/Intracoastal Waterway. The proposed work scope is the installation of interlocked articulating concrete blocks, and bank and shore ruble rip rap at the bridge piers.

- The complete scope includes the installation of flowable concrete fill at existing scour under bridge foundation pile caps and the installation of filter fabric as an underlayment under articulating concrete blocks and rip rap.
- The bridge was identified by the FDOT Scour Evaluation Report for Bridge No. 890093 (dated 3/9/12) to be a critical project for Martin County. The proposed work will provide scour protection of the piling systems and absolve the structure from FDOT Scour Critical designation.
- <u>Requested Grant Award</u> The total estimated project is \$1,485,760 (\$1,114,620 grant funds/\$371,140 local funds).
- <u>Budgetary Impact</u> SCOP grants require a 75%-25% fund match; \$371,140 (25%) to be funded with FY 27 Capital Improvement Funds (CIP).
- Annual Operating Cost
 - Annual maintenance cost is estimated to be \$3,000 per year.
 - Staffs time to administer the grant.

ALTERNATIVE ACTION:

- Programmatic Implication if not approved Identified project to remain unfunded
- <u>Financial Fiscal impact if not approved</u> Martin County will forfeit \$1,114,620 in grant funding.

 - Parties to the Agreement/Contract FDOT and Martin County Board of County Commissioners.
 - <u>Purpose of the Agreement/Contract</u> This Public Transportation Grant Agreement is for \$115,907 and requires a County match \$115,907 for a total project cost of \$231,814. These funds provide operating assistance for the Martin County Public transit bus service (Marty) in the non-urbanized area, specifically for the benefit of Indiantown residents.
 - New/Renewal/Modified –This is a new contract that is awarded annually.
 - **Duration** Starts upon execution date of contract and ends June 30, 2024.

- Duration October 1, 2020 through September 30, 2022.
- Benefits to Martin County Provides the funding that will enable the county to staff the radiological planner position, enhance planning projects, provide for technology upgrades, purchase equipment and supplies, and conduct the training and exercises required by mandate. Most importantly, this funding provides for the program needs to ensure the safety and protection of residents in the event of a radiological emergency.
- <u>Cost to Martin County</u> Administrative time to prepare semi-annual reports.
 There is no County funding match required.

ALTERNATIVE ACTION:

 <u>Programmatic Implication if not approved</u> – The entirety of the budget for radiological emergency planning is funded by Florida Power & Light as required by

 - <u>Parties to the Agreement/Contract</u> FIND and Martin County Board of County Commissioners.
 - Purpose of the Agreement/Contract On March 3, 2020 the Coastal Management Division of the Public Works Department was authorized to apply for the (FIND) Waterway Assistance Program Grant for the Manatee Pocket Managed Mooring Field project. The Manatee Pocket is located at the confluence of the St. Lucie River/Okeechobee Waterway, the Indian River Lagoon/Atlantic Intracoastal Waterway and the St. Lucie Inlet, within Port Salerno, FL. When constructed, the project will include 42 mooring buoys, a dinghy dock along to facilitate ingress and egress between the mooring field and the adjacent uplands and access to mooring field support facilities. The proposed Manatee Pocket Managed Mooring Field Project will provide a regulated and secure mooring opportunity to transient boaters, facilitating their access to upland facilities and nearby attractions in Port Salerno, Hobe Sound, Jensen Beach and Stuart. This is the second FIND grant contract awarded to this project. The FY 21 FIND Grant Contract # MA-20-88 for Manatee Pocket Mooring Fields is for \$200,000, \$100,000 less than requested.
 - New/Renewal/Modified This is a new contract.
 - <u>Duration</u>: execution through September 30, 2022, (the contract has the possibility to be extended to September 30, 2023 at the request of the County)
 - <u>Benefits to Martin County</u> Enables the County to Protect the St. Lucie River and Indian River Lagoon and provide an attractive amenity for transient boaters in the area.
 - Cost to Martin County Match of \$200,000 will come from a grant from the Florida Fish and Wildlife Commission contract #19030.

The Manatee Pocket is located at the confluence of the St. Lucie River/Okeechobee Waterway, the Indian River Lagoon/Atlantic Intracoastal Waterway and the St. Lucie Inlet, within Port Salerno, FL. When constructed, the project will include 42 mooring buoys and a dinghy dock to facilitate ingress and egress between the mooring field and the adjacent uplands including access to mooring field support facilities. The proposed Manatee Pocket Managed Mooring Field Project will provide a regulated and secure mooring opportunity to transient boaters, facilitating their access to upland facilities and nearby attractions in Port Salerno, Hobe Sound, Jensen Beach and Stuart. 10. BUDGET TRANSFER AND RESOLUTION TO FUND THE START-UP OF THE JENSEN BEACH MOORING FIELD

The Parks and Recreation Department is requesting \$41,712 for one-time purchases to start-up the Jensen Beach Mooring Field.

The one-time costs are necessary to fund the purchase of a truck, dingy tender and trailer, and operating equipment.

The Mooring Field Harbormaster will need the dingy tender to monitor, maintain and inspect the moorings as well as provide customer service to patrons that are moored. A truck is needed to maintain the facility and for transportation between Indian Riverside Park and the Mooring Field.

A Budget Transfer from General Fund Reserves is required for the one-time startup costs in the amount of \$41,712. The Office of Management and Budget requests approval of a Budget Resolution to appropriate the one-time starting costs into the Jensen Beach Mooring Field Budget.

The Parks and Recreation Department is requesting \$121,862 for one-time purchases to start-up the Seaside Café located at Stuart Beach.

The start-up costs are to fund the purchase of a vehicle, café signage, point of sale equipment, side curtains for the deck, ceiling fans, one TV, small wares for the kitchen and bar, chairs, tables and barstools for the dining area, beach chairs and umbrellas for beach chair service and for office equipment and furniture for the manager.

A vehicle is needed for transportation between cafes, moving equipment, and picking up operational supplies in cases where delivery is not provided.

A Budget Transfer from General Fund Reserves is required for the one-time startup costs in the amount of \$121,862. The Office of Management and Budget requests approval of a Budget Resolution to appropriate the one-time starting costs into the Seaside Café Budget.
