- 2. On August 21, 2019, an Order Finding Violation was issued by the Code Enforcement Magistrate to, SALVATORE & ADA CALIFANO, for the following violation(s):
 - Section 105.1 FBC- Permits Permits When Required Incorporated By Sec 21.1 General Ordinances, Martin County Code.

Compliance was required by September 30, 2019. On March 9, 2021, an Affidavit of Compliance/Accrued Fines was issued reflecting an outstanding fine of \$52,400.00 plus costs in the amount of \$575.00.

- 3. Staff has determined that a lien reduction is warranted. The respondent, brought the property into compliance and have offered to pay \$2,648.75 to resolve the outstanding fines which have accrued. Staff has taken into consideration that fact that the violation was a minor in nature for an expired permit and are accepting 5% of the total value of the accrued fine on this property.
