The Petitioner and Respondent hereby freely stipulate and agree to the following:

THIS MATTER having come before the Magistrate on March 17, 2021, and having heard the testimony and other evidence of the parties, and having been fully apprised of the circumstances, and based upon a preponderance of the evidence, does find as follows:

1. This Fine Reduction Stipulation and Agreed Recommended Order involves a parcel located on an unaddressed vacant lot, Martin County, Florida and further described as:

LOT 6, 7, 8, 9, 10, 11, 12 and 13 (LESS AND EXPECTED THE WEST 20 FEET OF LOTS 8 AND 9 BLOCK M THEREOF); TOGETHER WITH THAT PORTION OF ABANDONED ALLEY ADJACENT TO LOT S 6 THROUGH 13, INCLUSIVE, BLOCK M, PLAT OF CLEAVELAND ADDITION TO THE TOWN OF PALM CITY, ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK 10, PAGE(S), PAGE(S) 78, OF THE PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA. LAND SITUATE, LYING AND BEING IN MARTIN COUNTY, FLORIDA.

- 2. On September 18,2019, an Order Finding Violation was issued by the Code Enforcement Magistrate to PEGASUS I LLC, for the following violation(s):
 - 67.201.A Weeds- Nuisance Declared: Weeds, Undergrowth, General Ordinance, Martin County Code.

Compliance was required by October 31, 2019. On February 21, 2021, an Affidavit of Compliance/Accrued Fines was issued reflecting an outstanding fine of \$47,000.00 plus costs in the amount of \$575.00.

3. Staff has determined that a lien reduction is warranted. The Respondent brought the property into compliance and have offered to pay \$5,000.00 to resolve the outstanding fines which have accrued.
