Agenda Item: 19-0568 DIXIE HIGHWAY BEAUTIFICATION

George Dzama, Capital Projects Manager, Public Works Department gave a presentation on enhancements for Dixie Highway in the Golden Gate CRA is proposed to begin in January 2021 and be

completed by May of 2021. There will be added signage and street lighting in the medians. Sidewalks, bicycle lanes and crosswalks will be added at several locations along the route. This project is funded through an FDOT grant with the Public Works Department and the CRA funding some of the median improvements and the landscaping.

# Community input:

- Roundabout added at Indian St. and Dixie Hwy.
- Shorten turn lane at Indian St./Dixie Hwy going north.
- Take road down from 4 lanes to 2.
- Roundabouts along Dixie Hwy.
- Close off option to turn left out of Sunoco onto Dixie Hwy.

### Comments:

 Rob Ranieri, House of Hope requested that temporary crosswalks be installed until the project starts. Staff will follow up.

Mr. Dzama also presented the Golden Gate Neighborhood Restoration project. The Golden Gate Neighborhood Restoration project consists of complete drainage pipe replacement, drainage swale regrading, roadway resurfacing, sidewalk replacement, new traffic signs and pavement markings within the Golden Gate Subdivision in central Stuart, FL. All work is to be performed within the County owned Right-of-Way. The project is coordinated with the Martin County Utilities and Solid Waste Septic to Sewer project. Thus, the neighborhood will experience multiple phases of construction for drainage (2019), sewer (2020), roadway pavement resurfacing (2021).
