- Mr. Blatch water connection According to the Health Department, his address has never exceeded the Health Advisory Level or the Maximum Contaminant Levels for any chemicals tested for, and therefore they may not have been eligible for assistance. Mr. Blatch was directed to Contact the DEP Division or Water Restoration Assistance @ 850-245-2836. # Agenda Item: 20-0053, 2021 Capital Improvement Plan (CIP)

Susan Kores, Manager, Office of Community Development, presented the 2021 capital improvement projects for the Port Salerno CRA:

- S. Kores: This is an informative discussion and we will come back next meeting to ask for approval.
- E. Asselin: Have you finished the sidewalk repairs and connections?
- J. Mills: Our Safe Routes to School project has gone out for bid and currently in bid approval/review with FDOT. We hope for start of construction in February.
- E. Asselin: Is there any way of enforcing "no parking" on sidewalks?
- J. Mills: Possible solutions would be to call code enforcement, open a Request For Service with Martin County, or call the sheriff's office.
- C. Nash (MCSO): Call the sheriff's office, we will write tickets.
- E. Asselin: If we buy a lot, can we put a parking lot on it?
- E. Olsen: Owner of Pirate's Cove is working with the county for parking.
- S. Kores: We can only follow the rules we are given. We have \$75,000 unallocated funds, we can recommend putting it in a parking fund.
- Linda Russell: I live in Rocky Point and I am bothered by the crosswalks. The paint has worn off and they are dangerous, especially the ones on Salerno Road to US 1 and Cove Road.
- S. Kores: These repairs are funded through neighborhood enhancement

- J. Rolle-Taylor: I am extremely concerned about the curve off 47th and Cove Road. There is a blind spot there that is very dangerous for students, needs a speed hump.
- J. Mills: This location and the issues of having to extend your vehicle into traffic just to see if there is oncoming traffic was submitted to our Public Works Traffic Division in January. They deemed the trimmed back vegetation on the extended property/curve alleviated this issue. I will bring it back to their attention, though. [other NAC members expressed same concerns for this location]
- E. Asselin: What is the status of the LED lights?
- J. Mills: The LED light swap program is still active, but we have halted the actual "swapping" to better streamline the account numbers which is how they determine project boundaries.
- E. Olsen: We have a lot to think about between now and our next meeting when the CIP is up for approval.

#### **OLD BUSINESS**

#### Agenda Item: 20-0025, Port Salerno Water Installation

Josh Mills, Project Manager, Office of Community Development, presented an update on the Port Salerno Water Installation project.

 Official start date/kick-off for the project scope was September 9, 2019 between Martin County Public Utilities and our consultant. Martin County Public Utilities will be the engineer of record as well as obtaining the necessary permitting for the project. Instead of an 8-phase/year project, we've condensed to 2-phases and roughly two years. The water main for 43rd street is getting extended and Mrs. Washington will be able to connect once that project is complete.
