Agenda Item: 20-0375, CRA Capital Projects Update

Susan Kores, CRA Manager, presented the Capital Projects Update highlighting the Bridge Road project, the Port Salerno Safe Routes to School project, Mapp Road project, and the Ripple project grant update.

- M. Palazzo This was the second grant for Ripple and we already have the first grant correct? Is the plan to go ahead and get started with the initial funds we have under the first grant?
- S. Kores Yes, what I plan to do is go back to FDEP and move around some of the first money so that some if not all of the funds fall under construction. We won't do any monitoring until the end of the project, will be meeting with them next week. On another note, Lucy will be coming to the next meeting to present the art project for Ripple.

PRESENTATIONS

Agenda Item: 20-0378, CRA FY 2020 1st Quarter Report

Josh Mills, Project Manager, CRA presented the FY 2020 1st Quarter Report

COMMENTS

- M. Palazzo I have two questions. On the LDR approvals that are going on, we have received several letters at home, and I have received multiple questions from neighbors. My response has been that this is the public notification of what is going on at the BOCC and NAC meetings and nothing has changed. Is this correct?
- S. Kores There have been a few minor tweaks, but no major changes.
- M. Palazzo My second question now that you are doing Historic preservation, did that come with a budget to help fund those activities?
- S. Kores Yes
- C. Winters Has the Pettway calming been well received?
- S. Kores We did go down and look at the finished project. It looks fantastic and it makes the roadway easier to traverse. As we all know, it is ultimately up to the driver and whether they end up slowing down.
- C. Winters What about Park Drive has that been well received?
- J. Mills We spent some time speaking with the residents about this project and its purpose. Once they understood what the purpose is and the benefits, they were happy with the result
- S. Kores There are also some water quality issues there that we want to resolve, and the boardwalk area needs some assistance along with the mooring field project.
- C. Winters Will the mooring field project help with lighting?
- S. Kores We are looking at additional lighting on the land side.
- J. Mills -- The parks department has lighting in their long-range planning project.
- S. Tsaftarides Where are we on the Camino Trail?
- J. Mills Gave a quick update on the trail and explained that it is moving forward as planned.

NEW BUSINESS

Agenda Item: 20-0379, Metropolitan Planning Organization – Long Range Transportation Plan and Complete Streets

Beth Beltran, MPO Administrator and Bolivar Gomez, MPO Senior Planner presented the 2045 Long-Range Transportation Plan and Dr. Kim DeLaney, Director of Strategic Development and Policy, TCRPC presented the Complete Streets access to transit.

- M. Palazzo Is this planning just applicable to state roads or any roadway in Martin County?
- B. Beltran It is any roadway on our federal aid system. So that includes the arterials as well as the major collectors. So, it can be all roads that are eligible to get funding through the MPO process.
- R. Kennedy Do you handle parking as well?

- B. Beltran We are a planning organization, so yes we do studies, but we don't implement parking.
- R. Kennedy Any rail stations?
- B. Beltran Yes
- C. Winters Are you looking at new infrastructure as well?
- B. Beltran No, only transportation facilities.
- M. Palazzo Do you or are you looking at evolution of transportation for example electric vehicles.
- B. Gomez Yes, we do incorporate these.
- B. Beltran This is actually a required component for the LRTP so we are addressing it this time.
- M. Readling Thank you for coming in. I loved your video. How long are you planning to have the survey out there?
- B. Beltran At least through June so please take these out to your NAC meetings.

Questions for Kim DeLaney

- C. Hall What about the dedicated bike lanes at Salerno and Monterey that do not exist? Is this because there is not enough right of way?
- K. DeLaney Yes, this is the case.
- R. Kennedy The diagrams have the left turn lane left out; how do you get businesses to do this?
- K. DeLaney These are just examples. We would do traffic studies and it is a tradeoff, we have public safety needs and access needs.
- R. Kennedy Is the public notified so that they can express their concerns?
- K. DeLaney Yes, we conduct extensive outreach.
- M. Palazzo What is the linkage between this theory and actual events?
- K. DeLaney I have a map to answer this along with project selection criteria slides and transit nodes. Project Selection Criteria slides and Transit Node Networks were reviewed.
- M. Palazzo Does this include Marty stops?
- K. DeLaney Correspond to one another.
- B. Beltran Not a lot of choice, transit is usually an afterthought. We want to consider transit first in our complete street planning.
- M. Palazzo So you could implement complete streets and put in a transit stop or you could put in a transit stop and never implement complete streets? You don't have to do them both.
- B. Beltran The areas that were considered were within a transit stop purposely.
- S. Tsaftarides Does the Marty go to New Monrovia?
- R. Vazquez I don't believe so.
- K. Delaney Explained the transit focused analysis of baseline criteria, demographics and points system.
- M. Palazzo Can we get these slides?
- M. Banas What about the elevated bike lanes? The bike lanes seem to collect a lot of debris. What is the ratio of conflict to biker/pedestrian as opposed to biker/automobile?
- K. DeLaney That is a great question, I will hunt this data down.
- M. Palazzo How do you keep the bikes off the sidewalks?
- K. DeLaney It is a learned behavior, evolutionary over time. We are fortunate to have an MPO that is considering the changes and looking out for the CRA's. We change the modes, change the environment.
