Agenda Item: 20-0480, CRA Capital Projects Update

Susan Kores, CRA Manager, presented the CRA Capital Projects Update. The following projects were highlighted: Port Salerno Infrastructure Partnerships, Rio Neighborhood Sidewalks, Old Palm City Mapp Road Town Center, Old Palm City "Ripple" Project and Old Palm City Charlie Leighton Park.

NEW BUSINESS

Agenda Item: 20-0485, FY 2021 CRA Capital Improvement Project

Stephanie Merle, Budget Financial Manager, presented the FY 2021 CRA Capital Improvement Plan.

- C. Winters When do we request an additional bump in the 75% TIF funding if we want to?
- S. Merle We go to the BOCC April 7, 2020 for approval of the CIP for each CRA. If you want an
 increase, it would affect the CIP sheets and the entire budget. This would need to be presented
 before that date.
- M. Palazzo Can we make a motion to request a percentage higher than 75% for the next plan year?
- S. Tsaftarides How far can we go?
- S. Merle 95%.
- S. Tsaftarides Then we should ask for 95%.
- M. Banas Before we pick a number, Susan do you as staff think there is a number we would get, if any? What is realistic?
- S. Kores I think 95% would not be approved.
- M. Banas So if we are going to ask, let's ask for something that we are likely going to get.
- C. Winters Øne would think that for the NAC to deal with our infrastructure projects and that is
 what the BOCC likes, the infrastructure projects, then we need to emphasize that we need more
 money to deal with infrastructure. This would be a win win on both sides.
- S. Tsaftarides We can ask for 95% and if it is too high, they can bring it down.
- S. Kores It is up to you.
- C. Winters We need to be realistic as Mike was saying. Do we want to make a motion?

MOTION

- * M. Palazzo motioned that we start the process of asking for a TIF increase from 75% to 90%
- ** R. Kennedy seconded, and the motion carried 5 to 2 with S. Tsaftarides and M. Banas opposing
 - J. Priest An error was made many years ago by the property appraiser that was never corrected, and we lost millions in taxpayer dollars. I am just putting this back in your memory. Asking for an increase in TIF is certainly fair. I suggested a payment plan at the time and the BOCC never acted.
 - S. Tsaftarides That was a different board. Stuart asked for it and they got it back, we didn't.
- C. Winters So we are going to ask nicely Stephanie for the 90% increase.
- S. Merle I am not the decision maker; I am just the conduit.
- R. Kennedy Is this worth mentioning to the board that we did miss out on this money years ago and the City of Stuart did get the money?
- S. Kores I am not sure; I cannot speak for Stuart. I do believe the Indiantown monies were taken
 care of when they became a municipality. You can direct me to remind the board of this error. I
 would like that to come as a direction from the board.
- S. Tsaftarides Just a reminder that when this money came up, it was a different board.
- R. Kennedy I am not familiar with this; can someone talk about it?
- E. Lenihan There may have been a settlement of these issues.
- C. Winters Should we make a motion?

- M. Palazzo Was there a settlement issued? Can we get the details?
- S. Kores It was a miscalculation by the property appraiser's office of the amount of TIF that was owed.
- E. Lenihan It has not been pursued because I believe there was a settlement of the issues. We can come back to this board with more information.
- S. Merle We do have a little time before the final budget is adopted if we want to discuss this further.

MOTION

- * R. Kennedy motioned to direct staff to investigate the issue of the miscalculation of funds by the property appraiser and report back to us. Is it reasonable to go to the board and ask for these funds?
 - ** S. Tsaftarides seconded, and the motion carried UNAMIMOUSLY
 - S. Tsaftarides I would like to point out that in the CIP presentation, Golden Gate is District 2, not 4 as stated on the CIP sheet, if we could correct that error.
 - S. Merle Thank you for pointing that out, we can correct that before it goes to the board.
 - M. Palazzo To what extent should we be identifying and naming projects beyond 2021, 2022, 2023, 2024?
 - S. Merle Definitely it is better to plan out as far as possible, giving the board a clear plan. The good thing about the CRA is that you have a master plan and a CRA plan that has specific points that you are going to execute. It is difficult with TIF to estimate your dollars. The twist with the CRA's is that you must spend the money within 3 years, but yes if you have projects to present, please do so. An example is the Port Salerno infrastructure project where it is phased for three years.
 - S. Kores Just to add, it helps us to be nimble if we keep the numbers short term, not leaving those numbers unfunded and allows us to make shifts if we need to.
 - M. Palazzo Should the action go to each NAC and allow them to come up with 5-year projects?
 - S. Kores Surely you could do that and have the discussion on your committee level. We do have a plan in place with each NAC which is presented two times. If the individual NAC feels that changes need to be made, then we could do that.
 - M. Palazzo For example in Old Palm City, we have more projects than just the Mapp Road Town Center which is listed on the 2021 CIP. I know that we have many more projects that could certainly be listed and feel that the more justification we have for new projects, the more we can ask for. Just like the fact that we are going to ask the board for an increase to 90%, what are we going to spend the money on? If we have those projects listed, we can justify the ask for the funding.
 - S. Merle I would caution you in making priority shifts since these are public record. The public would be able to see future projects. For example, if you put it out there that we will possibly build something in the future, these are available on the web.
 - M. Palazzo Again, we know we have debt service on Mapp Road for many years.
 - S. Merle Our debt service is separate than the CIP.
 - C. Winters We currently have 75% TIF, if we do get approval for the 90%, how long does this new amount stay in effect? Do we have to ask for it every year?
 - S. Kores Until the board changes it. I believe it went to 75% in 2017.
 - M. Readling And where was it before that?
 - S. Kores 50%.

MOTION

- * M. Banas motioned to approve the 2021 Capital Improvement Project as presented and move to BOCC for approval
 - ** C. Hall seconded, and the motion carried UNAMIMOUSLY

NEW BUSINESS

2020 Census Count

Robyn Cryer, Partnership Specialist, Saint Lucie and Martin Counties, U.S. Census Bureau reported on the process for the 2020 Census Count that is mandated by US Congress. In 2010, when the last census was done in Martin County, 78% responded which left \$1600 unclaimed for each person who did not respond. Most people

do not realize how important it is for everyone to be counted, including children. The census will be mailed to each person on 3/12/2020. It is available on-line, and a toll-free number can be accessed and the people handling the census speak 12 languages.
