Susan Kores, CRA Manager, presented the CRA Capital Projects update highlighting Dixie Highway in Golden Gate, El Camino Trail in Golden Gate, Gomez Affordable Housing in Hobe Sound, Bridge Road in Hobe Sound,

Jensen Beach parking project on Church Street, Port Salerno and Rio water projects, Mapp Road in Old Palm City and the Ripple Project.

- C. Winters – How did we get the speed limit reduced to 25 mph on Bridge Road? Is this an option for Salerno Road?
- S. Kores – The crosswalks should help with the speeding problem on Salerno Road. We would have to bring the speed limit change to the BOCC after conducting speed studies.
