#### **PRESENTATIONS**

#### Agenda Item: 21-0929, Manatee Gateway Pelican Sculpture Project

Susan Kores, CRA Manager, presented the project. The artist, Ken Timblin was also on the phone to offer support, information and to answer any questions about the project.

- C. Hall So you are looking for us to approve the additional expenditure for the pelicans?
- S. Kores Yes, if we could do that then we could move the project forward.
- R. Kennedy Did the Port Salerno NAC increase their support by \$4,000?

- S. Kores No, we did not have the updated quotes in time to present to the NAC. It is always an option to go back and ask them as well.
- C. Winters Are the pelicans going to look more like the work Ken has shown us in the presentation as opposed to the abstract drawings?
- K. Timblin The commissioned pieces were by the water and are quite large. The seahorse is a committed piece that has kinetic parts. The turtle is more representative of the mosaic style and design. We will also be incorporating some of the glass pieces into the pelicans.
- C. Hall Will these need to be removed in hurricane events?
- S. Kores We are working with an engineer to advise us on this issue and will be able to report back to you by our next meeting. It might be that we just need to remove the kinetic parts.
- K. Timblin My design will be built into the wing structures that will hold up to 90 mph winds.
- R. Sentell Are you using the highest-grade stainless steel for this project?
- K. Timblin Yes, I will be using 304 stainless which is not aircraft grade, but it is a high grade used in outside construction. It is a high grade of stainless.
- C. Winters Will it look weathered as time goes on?
- K. Timblin Typically stainless will not weather, it holds up to the elements and holds it finish very well.
- C. Winters So you are asking for \$11,000 more from us?
- C. Hall No, we will be authorizing \$8,000 and this concerns me. The budget for 2022 would be depleted. Can we get the NAC to contribute \$4,000 more? How far back would that set us?
- S. Kores The next Salerno meeting is August 12<sup>th</sup>. It would put us back a month. We know how long these projects take, so if you are concerned about spending the money in 2022, we really do not have anything else going on in 2022.
- R. Kennedy Can we motion to allocate ½ of the funds \$4,000 with the stipulation that the NAC will contribute \$4,000 and move forward with approving the project?
- K. Storey Yes, you can make this motion.
- C. Winters Can we allocate the \$8,000 and ask the NAC to provide \$4,000?
- K. Storey You may ask them for a contribution to the project if approved.
- K. Storey I believe Mr. Kennedy has made a motion but has not received a 2<sup>nd</sup>.
