CONFIRMATION OF CHAD MICHAEL CIANCIULLI AS MARTIN COUNTY'S FIRE RESCUE DEPARTMENT FIRE CHIEF

EXECUTIVE SUMMARY:

Per Florida Statutes Section 125.74(k) "the employment of all department heads shall require confirmation by the Board of County Commissioners" (Board). Mr. Chad Michael Cianciulli is being recommended for the position of the County's Fire Rescue Department Director as the Fire Chief.

BACKGROUND/RELATED STRATEGIC GOAL:

The position of Fire Chief was initially vacated in October 2020 when then Chief Schobel left his employment via the Voluntary Early Separation Incentive Program (VESIP). Deputy Fire Chief Kevin Herndon was placed into the role of Interim Fire Chief to allow for a smooth transition and the least disruption to operations of the department. Battalion Chief, Chief Chad Cianciulli was placed into the position of Interim Deputy Chief to assist and maintain operations of the department. Chief Herndon recently decided to take advantage of the current VESIP being offered and leave his employment

with Martin County effective in March 2021, but due to an extensive amount of leave he had accumulated, his last physical presence in the department was at the end of January 2021. At that time, Chief Cianciulli was placed into the position of Interim Fire Chief to ensure operations continued with minimal disruption.

The position of Fire Chief was advertised internally with two candidates applying for the position. An interview panel was established with both candidates being interviewed on February 15, 2021. Chief Cianciulli was selected and is being recommended for confirmation as Fire Chief by the Board per Florida Statutes Section 125.74(k). Chief Cianciulli has been employed with Martin County for twenty-five years and has been promoted into various positions within the County's Fire Rescue operations as reflected in his resume which is included with this item. Upon a favorable confirmation, the County Administrator will formally present the Fire Chief with the appropriate Fire Rescue badge representing his promotion to Fire Chief.
