BACKGROUND/RELATED STRATEGIC GOAL:

- 1. Agreement/Contract drafted by: Martin County and the School Board of Martin County
- 2. Parties to the Agreement/Contract: Martin County and the School Board of Martin County
- 3. Purpose of the Agreement/Contract: Formalize the coordination of the emergency sheltering program
- 4. New/Renewal/Modification: Modification
- 5. Duration: Five years from the effective date; however, it cannot be terminated between June 1 and November 30 (hurricane season)
- 6. Cost to Martin County (annual and potential): Annual none; Potential school district cost of shelter operations during an emergency
