BACKGROUND/RELATED STRATEGIC GOAL:

At the May 8, 2018 meeting the Board adopted an ordinance related to operating PACE programs in Martin County and directed staff to negotiate with providers expressing a desire to provide for such services in Martin County. Negotiations have completed with Florida PACE Funding Agency (FPFA). In order to authorize FPFA to provide a PACE program in the unincorporated areas of Martin County, the Board and FPFA must enter into an Interlocal Agreement. The FPFA also requires that the
