Section 420.9075(10), Fla. Stat. requires each county to submit to the FHFC a report each year of its affordable housing programs and accomplishments. During the Board's September 11, 2018 meeting, the Board approved the tentative 2016/2017 SHIP Final Report which reported funds as encumbered, but a few projects had been delayed and were incomplete at the time.
